Approval of competent authority is hereby conveyed for formation of Vigilance and Telecom Monitoring (VTM) Wing under Sr.DDG (Vig.) at the following places:

1. Delhi
2. Mumbai
3. Hyderabad

Each unit will be headed by one SAG level officer and assisted by two JAG/STS and four JTS officers and they will be representing the licensor/telegraph authority in the field.

The Government Posts will be withdrawn from BSNL/MTNL for VTM Cells

**Financial Powers:-**

VTM Wing has been delegated the financial powers as has been delegated to the CCA offices vide letter no 7-5/2000-F&A dated 22-1-2001 and subsequent amendments.

**DDO functions**

Since the VTM field officers are being delegated with separate financial powers, they will designate one of the JTS officers as non-cheque drawing DDO who will maintain the cash book and other records, prepare contingent expenditure and salary bills, etc., effect relevant deductions and claims, and prefer the bill to CCA for pre-check and issue of cheque after approval by head of the VTM.

- 7) Technical arrangement for the lawful interception/monitoring of all the communications passing through the licensee's network.
- 8) Ascertaining that the licensee is providing the services within the permitted area.

Monitoring Functions:

- 1) Coordination and monitoring of various networks operators .
- 2) Roll-out obligation as per license condition.
- 3) Checking of the compliance by the licensee in respect of the license conditions and any directions issued by the licensor in public interest.
- 4) To ensure optimum Call Completion Ratio(CCR) for inter operator calls.
- 5) Matters related to National Security
- 6) Disaster Management- Taking over of network in the events of natural calamities or, other emergency situations.
- 7) Grievance Redressal of subscribers in respect of deficiency in service by various operators.
- 8) Perform such other functions as may be entrusted to it from time to time by the DOT in the overall interest of the country and consumers.
