This is an Appeal preferred by Shri T. Rajesh Kumar against the information provided by Shri Benoy Choudhary, Deputy Secretary(Admn.) & CPIO vide letter No. A-12028/29/2014-Admn.II dated 16-04-2014.

2. Shri T. Rajesh Kumar has filed an on-line appeal dated 16-04-2014(received through DS(Co-ord) on 25-04-2014) stating that no response has been received within the time limit for his on- line RTI application dated 15-03-2014 wherein he has asked for details of vacancies for 2014, recruiting organization, educational qualification, eligibility for No. of posts for a candidate with general degree, reason for less recruitment in telecommunication compared to other sectors etc.

3. The CPIO vide letter dated 16-04-2014 has sent the the requisite information by post. The RTI application dated 15-03-2014 was received by the CPIO on 21-03-2014 and the requisite information has been furnished by the CPIO on 16-04-2014. Hence, the requisite information has been furnished well within the time.

Decision

4. I find that the CPIO has conveyed the relevant information in respect of his division within 30 days from the date of receipt of the application. As desired, a scanned copy of the reply given on 16-04-2014 is also being sent on your e-mail id.

5. The appeal dated 16-04-2014 stands disposed off.

It is informed that Admn. II Section is dealing with establishment /administrative matter in respect of Indian Radio Regulatory Service (IRRS), Central Secretariat Stenographer Service and Miscellaneous Cadres. The details of Recruiting Organisation / Vacancies and educational qualification are as under:-
2	What are the educational qualifications for these posts.	(I) Indian Radio Regulatory Service (IRRS)
3	For how many posts a candidate with general degree is eligible.	For the posts of Engineer (Group "A" Service) (IRRS), the examination is conducted by Union Public Service Commission (UPSC) through Engineering Services Examination. The tentative vacancies in the Engineer Wireless Planning and Co-ordination/ Monitoring Organizaztion, Department of Telecommunications for the year 2014 for direct recruitment are 04. The educational qualification for the post of Engineer for these posts is as prescribed for combined Engineering Services Examination conducted by UPSC. For the post of Junior Wireless Officer (IRRS) (Group "B") the examination / Selection is being conducted by Staff Selection Commission. Since the cadre of Junior Wireless Officer has been merged with Junior Engineer (Wireless) w.e.f. 17-01-2014, the sanctioned strength is to be revised. The tentatiave vacancies for the year 2013-2014 will be decided only after the revision of the sanctioned strength. The Educational qualification for the post of Junior Wirerless Officer is Degree of a recognised University in Telecommunication Engineering / Electrical Engineering with Radio Communications / Electronics /Telecommunication as a special subject (OR) Master's Degree in Science with Physics and Radio Communication / Electronics / Telecommunication as a special subject. (II) Central Stenographer Secretariat Service (CSSS)
		Direct Recruitment in the grade of Steno "D" is being made by Department of Personnel & Training through Staff Selection Commission. (III) Miscellaneous Cadres The vacancies in respect of General Central Services (GCS) posts are filled by deputation basis. The recruitment for Official Language cadres is made through Department of Official Languages. The recruitment for Subordinate Statistical Service (SSS) is made through Department of Statistics and Programme Implementation.
4	What is the reason for less recruitment in telecommunication compared to other sectors.	The vacancies in the above mentioned cadres occur on account of resignation, voluntary retirement, retirement on superannuation, promotion to the next higher post etc.


