Subject: Engineering Services Examination, 2022- Allocation of candidates to the various services/posts on the basis of the results of.

The undersigned is directed to refer to the Union Public Service Commission's letter No. F.1/4(14)/2022/E.VII dated 10.01.2023 forwarding a list along with dossiers and other document of finally recommended candidates on the basis of Engineering Services Examination, 2022.

- 2. Against a total of 246 vacancies indented for various services under four disciplines viz. Civil Engineering, Mechanical Engineering, Electrical Engineering and Electronics and Telecommunications Engineering, the Commission had recommended only 213 candidates in accordance to Rule 13 (iv) of ESE 2022 Rules. Out of the 213 candidates recommended 34 belong to Scheduled Caste (SC), 17 to Scheduled Tribes (ST), 66 to Other Backward Classes (OBC), 16 to Economically Weaker Section (EWS) and 07 candidates belongs to Persons with Benchmark Disabilities (PwBD) for appointment to various services/posts. The remaining candidates for the unfilled vacancies in each category shall be requisitioned as per the Reserve List from the UPSC as per Rule 13 (v) of ESE 2022 Rule.
- 3. List detailing allocation of candidates to different services/post under the four discipline viz. Civil Engineering, Mechanical Engineering, Electrical Engineering and Electronics and Telecommunications Engineering are enclosed as **Annexure-I, II, III and IV** respectively. A statement showing the number of vacancies which could not be filled in various services/posts under the four disciplines are at **Annexure-IA, IIA, IIIA and IVA**. Some of these vacancies will be filled later by requisitioning candidates from the Reserve List of ESE-2022 maintained by Union Public Service Commission. The details of candidates left out in the allocation under the four disciplines are enclosed at **Annexure-IB, IIIB and IVB**.
- 4. Allocation of candidates has been done, keeping in view the provisions of the Engineering Services Examination Rules-2022, strictly on the basis of ranks secured by the candidates, order of preferences for various services/posts exercised, medical requirements of various services and medical fitness of the candidates for services allotted, availability of vacancies in their category at their turn and physical requirements/functional classification, as prescribed for the various services/posts as against the physical requirements/functional classification possessed by the candidates. As regards allocation of PwBD candidates, if a PwBD candidate is not available the vacancy has been allotted to the candidate of the category concerned. In such cases only the reservation is carried forward by the CCA (as the reservation for PwBD is horizontal).
 - 4.1 (i) In column 7 of Annexure I, II, III & IV the category of the candidates shown (i.e. EWS. OBC, SC and ST) indicates that the reserved category candidates have been recommended on general merit and allocated UR vacancy. Equal number of candidates belonging to these reserved categories will be requisitioned from the Reserve List of 2022 in terms of rule 13 of ESE Rules-2022.
 - (ii) UR category shown in column 7 of Annexure I, II, III & IV indicates that the reserved category candidates recommended on general merit has been allocated against his/her own reserved category to ensure his/her higher preference of the service/post. Equal number of candidates belonging to UR category against adjustment of higher preference of the service/post by reserved category candidates will be requisitioned from the Reserve List of

4.2 As per the Final vacancy statement of ESE-2022 forwarded by UPSC, 07 vacancies are reserved for the Persons with Benchmark Disabilities. Service wise PwBD vacancy and functional classification (FC) and Physical Requirement(PR) required as per ESE – 2022 Rule in each services is mentioned below:

- 4.3 The allotment of "Temporary Unfit" candidates whose final medical status are pending have been made provisional. Due to the same, the allotment of the candidates who are below their rank in their category are also provisional subject to change in accordance with the final medical status of these candidate. The details of the provisional allotment of the candidates in the concerned discipline viz., Electronics and Telecommunication is indicated in Annexure IV.
- 4.4 The dossiers of all these candidates will be forwarded to CCA concerned/UPSC only on finalization of their medical status and subsequent final allocation of the candidates to the services as per ESE Rules and their order of preference.
- 5. Medical Reports of candidates, clearances in respect of candidature of candidates (Provisional-I, Provisional-II/ Conditional) received from UPSC have been placed in their respective dossiers.
- 6. Claim of candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (OBC) or Economically Weaker Sections (EWS) have been accepted by the Commission on the basis of the Original Certificates/ Income & Asset certificates (in case of EWS) submitted by them. Copies of these Certificates submitted by the candidates have been placed in their respective dossiers by the UPSC itself. In case of doubt regarding genuineness / claim of the candidate regarding his/her community (i.e Scheduled Caste/ Scheduled Tribe/ OBC) or Income & Asset certificates (in case of EWS), the Cadre Controlling Authorities /Participating Ministries may, if they consider it necessary, verify the further genuineness of these documents at their end. There may be some cases where though the OBC certificates have been issued to the candidates, the "Creamy Layer" status may be doubtful keeping in view the income/status of the parents of the candidates as per declaration of the candidates vide column 11 in the Detailed Application Form. It is advised that participating Ministries may, in such cases, ensure that candidates do not attract "Creamy Layer" provision and offers of appointment to these candidates may be made after the Ministry/CCA concerned satisfies itself in this respect also.

- 7. Verification of character and antecedents in respect of the candidates indicated in **Annexure I, II, III & IV** is to be done by the Cadre Controlling Authorities concerned to their satisfaction as stipulated in DOP&T's OM No. 13012/1/2007-AIS-I dated 27.06.2007 and 4.1.2008 and DOP&T's OM No. 18011/29s)/2016-Estt.(B)(i) dated 29.06.2016. The cadre controlling Ministries / Departments are requested to obtain Attestation Forms from candidates allotted to services/posts under their control for the purpose of verification of their character and antecedents from the district Authorities concerned. Pending such verification participating Ministries are advised to inform candidates that offers of appointment issued are provisional subject to clearance from the Cadre Controlling Authority regarding completion of verification of their character and antecedents.
- 8. Details of 01 candidate whose candidature is still marked as "Provisional-II" due to discrepancy in Caste Certificate indicated against his name, is given in Annexure-V. UPSC has obtained clarification from the candidate and placed the same in his dossier. As regards clearance of his Provisional candidature, UPSC has advised that CCA concerned may take further necessary action /decision themselves as per instruction/guidelines of the Government on the subject and the Commission's clearance would not be required. The Commission may be informed about the development of this case from time to time for record.
- 9. Details of 06 candidates whose candidature is still **conditional** on account of non -submission of certain documents as indicated against their name are given in **Annexure-VI**. The said documents may be sent to Union Public Service Commission at the earliest for clearance of conditionality. Offers of appointment to these candidates need not, however, be withheld on this account, if the candidates are otherwise eligible.
- 10. While issuing offers of appointment instructions issued from time to time by the Union Public Service Commission and DoP&T may be followed. In addition, clause relating to verification/acceptance of caste certificates etc. may also please be incorporated in the appointment letters clearly bringing out that if at any stage it is found that any Certificate/Document/testimonial etc. as furnished by the candidate and having a bearing on his/her eligibility is not in order, his/her appointment shall be cancelled forthwith without prejudice to any punitive action under the relevant rules.
- 11. It is advised that arrangements for additional training and coaching to the candidates belonging to the Scheduled Caste/ Scheduled Tribe candidates except those who have cleared on merit and not on category base may please be made in terms of Ministry of Home Affairs OM no. 2/11/55- RPS dated 7th May 1995 and in respect of OBC candidates vide Commission's Order No. 3/06/2003-C.II dated 16.04.2004 so that they may come up to the standard of other direct recruits appointed along with them. List of names of candidates belonging to the reserve communities who have qualified the examination and who may not required additional training, is given in **Annexure-VII**.
- 12. No departmental candidate (under age concession) has been recommended by the Commission.
- UPSC may please be kept informed from time to time about the position of appointment of these candidates. Copies of offers of appointment as and when issued to them may please be endorsed to the UPSC and to this Department and the dates of joining of candidates may also be advised subsequently. Assessment reports on the work & performance of the candidates may be made available to the Commission every year for a period of 5 years subsequent to their appointments. Copies of the Gazette Notifications appointing the candidates to the service to which they have been allotted may also be sent to the UPSC is due course.
- 14. In case the candidates do not accept offer of appointments, their dossiers may please be returned to UPSC directly under intimation to this Office. Replacements against such candidates will not be provided. A vacancy against which a candidate has been allotted is deemed to be filled up for all purposes. It may please to noted that UPSC has time to time reiterated that Reserve List is not a waiting list to cater to vacancies arising out of other reasons such as candidates not turning up to join, being found medically unfit, left out on account of medical fitness for limited services, resignation or any other reasons.
