On the basis of the results of the Engineering Services Examination-2013 held by Union Public Service Commission for recruitment to various Engineering Services under Government of India, the President is pleased to <u>offer</u> you <u>appointment to the post of Assistant Divisional Engineer Telecom</u> (ITS) Group 'A' in the Pay Band of ₹. 15,600-39,100/- with the Grade Pay of ₹. 5400/-

in the Department of Telecommunications, Ministry of Communications & Information Technology, New Delhi on provisional basis.

- 2.1. It may be mentioned that you will be in the grade of Junior Time Scale (JTS) of Indian Telecommunications Service on probation for a period of **two years** from the date of appointment in the Service. The Competent Authority may extend the period of probation in accordance with the orders and instructions issued by the Government in this behalf from time to time. On your completion of the period of probation or an extension thereof, you shall, if considered fit for the service, be considered for confirmation.
- 2.2. If during the period of probation or any extension thereof, as the case may be, the Competent Authority is of the opinion that you are not fit for service, it may terminate or revert you, as the case may be, or pass such orders as it may deem fit.
- 2.3. During the period of probation or any extension of thereof, you are required to undergo such training and instructions and to pass such examination and tests (including examination in Hindi) as prescribed by the Competent Authority from time to time.
- 2.4. As regards matters relating to probation, if not covered by these rules, the members of the Service shall be governed by the instructions issued from time to time by Government in this regard.
- 3.1. The officers appointed to the Service shall be liable to serve anywhere in or outside India.
- 3.2.1 It may also be noted that on your appointment to the Service, if so required, you shall be liable to serve in any Defence Service or post connected with the Defence of India, for a period of not less than four years including the period spent on training, if any;
- 3.2.2 Provided that such officer,
  - Shall not ordinarily be required to serve as aforesaid on expiry of ten years from the date of his/her appointment to this Service or from the date of his / her joining prior to the initial constitution of the service;
  - (ii). Shall not ordinarily be required to serve as aforesaid if he/she has attained the age of forty (40) years.
