- 1. This hearing has been done through hybrid mode.
- 2. The present suit was filed by the Plaintiff in order to restrain the Defendants from infringing broadcast reproduction rights by hosting, streaming, broadcasting, making available for viewing, providing access to and communicating to the public pirated content over sporting matches/events. Pursuant to which an *ex parte ad interim* injunction was granted vide Order dated 14<sup>th</sup> July, 2022. The said order directed to restrain Defendants Nos. 1 26 from telecasting, broadcasting, streaming or in any manner making available to the public any of the covered events; the DoT to block a total of 30 websites; the DoT and the ISP's, i.e., Defendants Nos. 40 48 to block the URL's; and the DNR's, i.e., Defendants Nos. 28 39 to reveal the identity of all the registrants of the websites.

## I.A.12618/2022 (u/O XXXIX Rule 2A CPC)

3. This is an application under Order XXXIX Rule 2A CPC filed by the

Plaintiff. The allegation in the application is that the order dated 14th July, 2022, insofar as the blocking of Defendant No. 22 - www.20bet.com is concerned, has not been given effect to by the Department of Telecommunications ('DoT').

- 4. Ld. Counsel appearing for the DoT submits that the URL for the above-mentioned website is a secured URL and in order to block the URL the entire website itself would have to be blocked.
- 5. The allegation is that several matches are being streamed on the said website and screenshots to substantiate the violation have been placed on record. In view thereof, DoT is directed to block the entire website <a href="https://www.20bet.com">www.20bet.com</a> within 48 hours and give directions to the ISPs to ensure implementation.
- 6. *I.A.12618/2022* for contempt is disposed of.
