# **I.A.** 15397/2023 (under Order I Rule 10 of the CPC)

- 1. The plaintiff seeks, by this application, to implead the domain <a href="https://tataneu.shop">https://tataneu.shop</a>, which also infringes the plaintiff's registered trademark TATA NEU and/or NEU and seeks extension of the order of injunction already passed to the said new domain.
- 2. Mr. Prithvi Singh, learned Counsel for the plaintiff submits that Defendant 1 is the registrant of the <a href="https://tataneu.shop">https://tataneu.shop</a> as well, though the Domain Name Registrar is the proposed Defendant 11, HOSTINGER Operations, UAB.
- 3. As such, HOSTINGER Operations, UAB is permitted to be impleaded as Defendant 11, presently with the email ids <a href="mailto:support@hostinger.com">support@hostinger.com</a> and <a href="mailto:abuse@hostinger.com">abuse@hostinger.com</a> as Defendant 11.

Defendant 11 is directed forthwith to block access to the domain <a href="https://tataneu.shop">https://tataneu.shop</a> and to maintain *status quo* with respect to the said domain during pendency of the present proceedings. Defendant 11 is also directed to disclose the details of the registrant of the said domain name in the affidavit to be filed by way of response to this application.

- **4.** Defendant 9 is directed to issue a notification calling upon various internet telecom service providers registered under it to block access to the domain name <a href="https://tataneu.shop">https://tataneu.shop</a>.
- **5.** This application stands allowed accordingly.
- **6.** The amended memo of parties filed with the application is taken on record.
- 7. This matter was also to be taken up today for consideration of the prayer of Defendant 8 for a direction to the plaintiff to bear the costs of successive renewals of continued registration of the infringing domains registered with Defendant 8, as enlisted in paras 20 to 22 of the plaint. Mr. Kevlani submits that, if the renewal costs are not paid, the domain names would, on the expiry of the term of the license, be available in the public domain for anyone else to purchase. In that event, Defendant 8 could not continue to hold on to the lock presently placed on the said domain name unless the cost of renewal is born by Defendant 8 itself.
- **8.** Mr. Prithvi Singh suggests a via media. He submits that, if the allegedly infringing domain names are transferred to the plaintiff, the plaintiff is willing to bear the costs of their successive renewals. Mr. Kevlani also submits that this can function as an interim arrangement,

which would solve the present imbroglio. In view thereof, Defendant 8 is directed to transfer the <a href="https://tataneu.shop">https://tataneu.shop</a> domain name to the plaintiff. The plaintiff would, subject to the outcome of the present proceedings, bear the costs of successive renewals of the said domain names. Para 3 of the order dated 31 July 2023, as already modified *vide* order dated 2 August 2023, shall further stand modified to the
