- b. disclose the identity, correspondence details and billing details of the registrant of the domain of the Defendant Nos. 41 and 42 (*viz* btcmovies.xyz and khatrimaza.casa) or such other domain names that may subsequently be notified by the Plaintiffs (on affidavit) to be responsible for infringing Plaintiffs exclusive rights;
- iii) Pass an order directing the Defendant Nos. 4 7 to 55, their directors, partners, proprietors, officers, affiliates, servants, employees, and all others in capacity of principal or agent acting for and on their behalf, or anyone claiming through, by or under it, to block access to the various domains identified by the Plaintiffs in the instant suit at S. No. 1 of the Documents which

It is stated that the plaintiffs have exclusive rights to communicate to the public the content of the film. It is stated that no other entity can, without authorisation from the plaintiffs, make available for download or communicate to the public, through any transmission, platform including internet, the said film.
- 3. It is stated that defendants No. 1 to 42, as revealed from their past conduct, substantially indulge in online piracy by making available for CS(COMM) 364/2021 page 3 of 5

download and providing access to infringing and illegal content. It is stated that defendants No. 1 to 42 are anonymous in nature and the information provided in the public domain regarding the owners of the websites are either incomplete or incorrect.

- 4. Defendants No.43 to 45 are said to be the producers of the film in question. It is further stated that defendant No. 46 is the domain name registrar of defendants No. 41 and 42. Similarly, defendants No. 47 to 55 are the various internet and telecom services providers. Defendants No. 56 and 57, it is stated, which are Government entities are impleaded to assist in enforcing compliance of the injunction orders of this court.
- 5. It is the case of the plaintiffs that the said film 'Bhuj: The Pride of India' is likely to be released on 13.08.2021 and the plaintiffs apprehend that the said defendants No. 1 to 42 would violate the copyright and other rights of the plaintiffs by broadcasting or in any other manner dealing with the aforesaid film which would cause irreparable harm and damage to the plaintiffs.
- 6. The plaintiffs have made out a prima facie case. A direction is passed against defendant No. 46 directing defendant No. 46 to suspend the domain registration of defendants No. 41 and 42 and any other domain names identified subsequently by the plaintiffs on an affidavit to be filed in court. An interim injunction is also passed directing defendants No. 47 to 55, their partners, owners, etc. to take steps to block access to the various domains identified by the plaintiffs at Serial No. 1 of the documents list filed by the plaintiffs who are said to be responsible for hosting, reproducing, streaming, etc. and any other domain names identified subsequently by the plaintiffs on an affidavit to be filed in court, the aforesaid film of the plaintiffs amounting to infringement of the plaintiffs' copyright. A direction is also passed to defendants No. 56 and 57 to issue a notification calling upon the various internet and telecom service providers registered under it to block access to the various domains identified by the plaintiffs in the instant suit at Serial No. 1 of the documents as noted above or any other domain names which are identified subsequently by the plaintiffs on an affidavit to be filed in court. The defendants will take immediate steps on the orders passed today by this court which will be uploaded on the website."
