The Plaintiff above named *showeth* as under:

1. The Plaintiff has filed the present suit seeking a permanent injunction restraining infringement of the Plaintiff's registered trademarks "BURGER KING", "BK", Crescent Logo Design



and the Hamburger Refresh Design Logo -

passing off, dilution, damages, rendition of accounts, delivery up etc. The present suit is pending before this Hon'ble Court and the plaint may kindly be referred to.

2. In the present suit, the Plaintiff had demonstrated the manner in which the Defendant Nos. 1 to 3 and Defendant No. 12, i.e., the unidentified John Doe Defendants (hereinafter collectively referred to as the 'Main Defendants') are duping innocent persons. The Main Defendants are communicating with persons seeking a BURGER KING franchise and issuing documents such as "approval letters" and "letter of intent" and

"invoices" by misusing the Plaintiff's registered trademarks

BURGER KING and the logos and letters of intent issued by the Main Defendants also contain bank account details for transfer of funds. Since innocent persons were being duped on account of this fraud, several of them had written to the Plaintiff's Indian master franchisee and these complaints had been filed along with the plaint. Accordingly, this Hon'ble Court had passed an ad-interim injunction order dated May 10, 2022.

- 3. Subsequently, in early June 2022 the Plaintiff learned that the Main Defendants had obtained registration of new domain names, i.e., www.burgerkingfranchises.com and www.burgerkingfranchise.in and were also using a different bank account to continue with their infringing activities. The Plaintiff immediately filed I.A. No. 11730 of 2022 under Order XXXIX Rules 1 and 2 of the Code of Civil Procedure, 1908. The infringing domain names were blocked upon advance service of the said application and the new bank account was frozen vide this Hon'ble Court's order dated November 24, 2022.
- 4. Thereafter in November 2022, the Plaintiff's Indian master franchisee received more complaints from victims of the Defendants fraudulent activities. These complainants revealed that the Main Defendants had obtained registration of two more domain names www.burgerkingfranchaise.com and

www.burgerkingfranchaise.in and opened five new bank accounts 110054628296, 110078859893, 110080686442, 110084817397 and 110069829830 with Defendant No. 15, i.e., Canara Bank Ltd. in order to continue their illegal operations. Accordingly, the Plaintiff filed I.A. Nos. 21036 of 2022 and 22069 of 2022 *inter alia* seeking directions for freezing the five new bank accounts registered with Defendant No. 15 and disclosure of the details of the account holders. Vide orders dated December 21 and 22, 2022, this Hon'ble Court allowed the Plaintiff's applications and *inter alia* passed directions to Defendant No. 15 to freeze the five new bank accounts and disclose KYC details of the account holders.

- 5. In late December 2022, the Plaintiff's Indian master franchisee received another complaint which revealed that the Main Defendants had opened a new bank account with Defendant No. 17, Yes Bank Limited bearing number 061899500164311. The Plaintiff filed I.A. No. 169 of 2023 *inter alia* seeking directions for freezing the newly discovered bank account and disclosure of details of the account holder. On January 6, 2023, this Hon'ble Court allowed the Plaintiff's aforementioned application.
- 6. In January 2023 the Plaintiff's Indian master franchisee received several more complaints which revealed that the Main Defendants had obtained registration of six (6) new domain names namely www.burgerkingfranchise.co.in, www.burgerkingfranchise.co, www.burgerkingfranchise.co, www.burgerkingfranchise.co, www.burgerkingind.com, <a

www.burgerkingbusiness.com and opened a new Bank account with Defendant No. 18 (HDFC Bank Limited) bearing number 50100581778775. These complaints also revealed that the Main Defendants were using the mobile numbers +91 7044930161 and +91 8961407473 both of which are registered with Defendant No. 10 (Bharti Airtel Limited). The Plaintiff immediately filed I.A. No. 1932 of 2023 under Order XXXIX Rules 1 and 2 read with Section 151 of the Code of Civil Procedure, 1908 and vide order dated February 1, 2023 this Hon'ble Court passed directions for suspension of the aforementioned six domain names, freezing the HDFC bank account and disclosure of identity and KYC documents of the HDFC bank account and the mobile numbers being used by the Main Defendants.

- 7. Recently, the Plaintiff's Indian master franchisee has received more complaints and the Plaintiff has also conducted independent enquiries, which have revealed the following:
 - a. The Main Defendants have obtained registration of the following new domain names -

b. The Main Defendants had also opened three new bank accounts with Defendant No. 18 (HDFC Bank Limited), the details of which have been provided hereinbelow:

- c. While the website www.burgerkingfranchaise.in has been blocked by Defendant No. 16 (GoDaddy.com, LLC) following this Hon'ble Court's order dated December 21, 2023, however, the Main Defendants appear to have continued use of the email address info@burgerkingfranchaise.in.
- d. The Main Defendants are also using the email address <u>franchise@burgerkingbusiness.com</u> to communicate with their victims.

- e. The Main Defendants are contacting their victims using the mobile numbers (i) +91 8961292537 and (ii) +91 8167393808. A truecaller search conducted by the Plaintiff has revealed that all the aforementioned mobile numbers are registered with Defendant No. 10 (Bharti Airtel Limited).
- 8. These new complaints have yet again confirmed that despite the numerous injunction orders passed by this Hon'ble Court, the Main Defendants have continued their fraudulent and illegal activities thereby intentionally and blatantly violating this Hon'ble Court's order dated May 10, 2022.
- 9. In light of the foregoing, the Plaintiff is seeking issuance of directions for suspension of the two new fraudulent domain names (i) www.burgerkingbusiness.com and (ii) www.indiaburgerkingfranchise.in to Defendant Nos. 1 to 3 and 12 as well as the respective domain name registrars and directions to Defendant No. 18 (HDFC Bank Limited) to freeze the bank account numbers 50100562887799, 50100433634535 and 50100542394491 and disclose on affidavit the identity of the account holder, KYC documents, identity related documents and bank statements from the date of opening of the accounts till date. It is pertinent to mention that under identical circumstances, this Hon'ble Court has previously granted similar relief to the Plaintiff vide orders dated May 10, November 24, December 21, December 22, 2022, January 6 and February 1, 2023.
- 10. The Plaintiff is also seeking issuance of directions to Defendant No. 10, i.e., the network provider of the newly

discovered mobile numbers (i) +91 8961292537 and (ii) +91 8167393808, to disclose on affidavit the CDR cell ID of the aforementioned mobile numbers along with the complete identity, i.e., name, address, phone number, e-mail ID, billing and payment details, KYC documents, identity related documents of the respective subscribers of the mobile numbers (i) +91 8961292537 and (ii) +91 8167393808 along with the last 10 GPS locations of the said phone numbers. Vide orders dated May 10, 2022, January 6 and February 1, 2023 this Hon'ble Court had passed similar directions to Defendant No. 10. Hence, the present application.

11.It is submitted that it is clear from the above that the Plaintiff has a strong prima facie case in its favour. The Plaintiff is suffering irreparable and incalculable loss of goodwill and reputation on account of the continued infringing activities of the Main Defendants. The balance of convenience is also in favour of the Plaintiff and it is imperative that this Hon'ble Court passes urgent orders to protect the interests of the public who are being duped on account of the Main Defendants' fraudulent activities mentioned hereinabove.

PRAYER

- 12. Keeping in view the aforesaid circumstances, it is respectfully prayed before this Hon'ble Court that it may be pleased to grant the following reliefs to the Plaintiff:
 - a. An order directing for suspension of the domain names (i)

 www.burgerkingbusiness.com and (ii)

 www.indiaburgerkingfranchise.in by Defendant No. 1

(Swapnil Patil), Defendant No. 2 (Vinay Nayak), Defendant No. 3 (Shushil Jadhav), Defendant No. 12 (John Doe Defendant) and the respective domain name registrars.

- b. An order directing Defendant Nos. 6 and 7, i.e., Ministry of Communications and Ministry of Electronics & Information Technology respectively to issue directions to all ISPs to block the website available at the domain names

 www.burgerkingbusiness.com
 www.indiaburgerkingfranchise.in
 so that the same are not accessible and file an affidavit of compliance within a time period specified by this Hon'ble Court.
- c. An order for directing Defendant No. 16 (GoDaddy.com, LLC) to suspend the email address info@burgerkingfranchaise.in and file an affidavit of compliance within a time period specified by this Hon'ble Court;
- d. An order directing for suspension of the email address franchise@burgerkingbusiness.com by Defendant No. 1 (Swapnil Patil), Defendant No. 2 (Vinay Nayak), Defendant No. 3 (Shushil Jadhav), Defendant No. 12 (John Doe Defendant) and the respective domain name registrars.
- e. An order directing Defendant No. 18, HDFC Bank Limited, to immediately freeze the bank account numbers 50100562887799, 50100433634535 and 50100542394491 and file an affidavit of compliance within a time period specified by this Hon'ble Court;

- f. An order directing Defendant No. 18, HDFC Bank Limited, to disclose on affidavit the identity of the account holder of bank account numbers 50100562887799, 50100433634535 and 50100542394491, KYC documents, identity related documents and bank statements from the date of opening of the accounts till date, within a time period specified by this Hon'ble Court:
- g. An order directing Defendant No. 10, Bharti Airtel Limited, to disclose on affidavit the CDR cell ID along with complete identity, i.e., names, address, phone number, email IDs, billing and payment details, KYC documents, identity related documents of the subscribers of the phone number (i) +91 8961292537 and (ii) +91 8167393808 along with the last 10 GPS locations of the said phone numbers, within a stipulated time period specified by this Hon'ble Court;
