- 1. This application seeks permission to file additional documents.
- 2. The plaintiff is permitted to place additional documents on record in accordance with Order XI Rule 1(4) of the Code of Civil Procedure, 1908 (CPC) as amended by the Commercial Courts Act, 2015 within 30 days from today.
- **3.** The application stands disposed of accordingly.

I.A. 3741/2023 (Exemption)

- **4.** Subject to the plaintiff filing legible copies of any dim or illegible documents on which it may seek to place reliance within four weeks from today, exemption is granted for the present.
- **5.** The application is allowed accordingly

I.A. 3742/2023 (under Section 12A of the Commercial Courts Act, 2015)

- **6.** In view of the judgment of the Division Bench of this Court in *Chandra Kishore Chaurasia v. R.A. Perfumery Works Pvt Ltd*¹, exemption is granted from the requirement of pre-institution mediation under Section 12A of the Commercial Courts Act.
- 7. The application stands allowed accordingly.

- 8. The plaintiff is aggrieved by the sale of counterfeit products, by unknown defendants, who have posted their products on websites, the WHOIS details of which are masked. The plaintiff has, therefore, not been able to identify the registrants of the websites over which the impugned products are being sold and has, therefore, impleaded them in an omnibus fashion as "Ashok Kumar", the local cousin of John Doe.
- **9.** The plaintiff claims to have commenced using the "NEW BALANCE" trade mark in the U.S. in 1951, and, in India, both as word mark and device mark since 1986. The plaintiff is the holder of the following registrations in India:

- 10. The plaintiff claims, in February 2023, to have become aware of the fact that, on the website of www.luxurytag.in, duplicate products, mimicking the products of the plaintiff's and using identical device marks, were being sold. To the credit of the owners of the said website, it must be said that they have been upfront with respect to their unwholesome intentions, and have declared, in so many words, on their websites, that they sell only replica and duplicates and that no original products are available on the website.
- **11.** *Prima facie*, therefore, there is no dispute about the fact that the unknown defendants, operating over the websites www.luxurytag.in are indulging in counterfeiting of the products of the plaintiff.
- **12.** The plaintiff has also placed on record various judicial orders, whereby its marks have been accorded protection by this Court.
- 13. In these circumstances, the plaintiff has moved this court by means of the present suit, seeking, essentially, an injunction against the defendants from using, in any manner, the plaintiff's registered



BALANCE", apart from ancillary reliefs of declaration, rendition of accounts, delivery-up and costs and damages.

- **14.** In the circumstances, let the plaint be registered as a suit.
- **15.** Issue summons in the suit.
- **16.** Written statement, accompanied by affidavit of admission and denial of the documents filed by the plaintiff be filed within 30 days with advance copy to learned Counsel for the plaintiff who may file replication thereto, accompanied by affidavit of admission and denial of the documents filed by the defendants within 30 days thereof.
- 17. List before the learned Joint Registrar (Judicial) for completion of the pleadings, admission and denial of documents and marking of exhibits on 23rd March 2023, whereafter the matter would be placed before the Court for case management hearing and further proceedings.

I.A. 3739/2023 (under Order XXXIX Rules 1 and 2 of CPC)

- **18.** By this application, under Order XXXIX Rules 1 and 2 of the Code of Civil Procedure, 1908 (CPC), the plaintiff seeks interim injunctive and directive reliefs.

- b) An order for interim injunction restraining the Defendant/Non Applicant No. 1, its proprietor(s) or partner(s) employees, agents, dealers, licensees, companies, retailers, wholesalers, distributors or any persons/entities that are under the control of the Defendant/Non-Applicant No. 1 or are related or affiliated to the Defendant/Non-Applicant No. 1, as the case may be, and all others, acting for and on behalf of the Defendant/Non-Applicant No. 1 from passing off the Plaintiffs NEW BALANCE, N Device and NB Device marks (as defined in paragraph 2 above);
- c) An order directing the Defendant/Non-Applicant No.2 to provide contact details/addresses of the Defendant/Non-Applicant No. 1 and lock/deactivate/cancel/block/disable/suspend access to the domain name LUXURYTAG.IN, and any other domain name found during the proceedings to have been engaging in or carrying out fraudulent activities by infringement of the Plaintiffs Marks;
- d) An order directing Defendant/Non-Applicant No. 3 to provide complete details complete details of the particulars of owners/operators of Defendant/Non-Applicant No. 1 's website located at www.luxurytag.in registered in its database to this Hon'ble Court and the Plaintiff/Applicant's Indian representatives;
- e) An order directing the Defendant/Non-Applicant No. 4 to provide details of the mobile number, (+91) 7750098927, to the Hon'ble Court and the Plaintiff/Applicant's Indian representatives;
- f) An order directing the Defendant/Non-Applicant No. 5 to suspend/freeze the bank account associated with

- the UPI ID <u>cca.136404(a)icici</u> and Transaction ID 303495360758 and furnish the details of account holders of the bank account to this Hon'ble Court and the Plaintiff/Applicant's Indian representatives;
- g) An order directing the Defendant/Non-Applicant No.6 to furnish details of the owners/operators of Defendant/Non-Applicant No. 1 's website located at www.luxurytag.in registered in its database to this Hon'ble Court and the Plaintiff/Applicant's Indian representatives;
- h) An order directing the Defendant/Non-Applicant No. 7 to suspend/block the WhatsApp account, linked with the mobile number (+91)7750098927, and to provide complete details of the owner of the WhatsApp account linked with mobile number (+91)7750098927 to this Hon'ble Court and the Plaintiff/ Applicant's Indian representatives;
- i) An order directing the Defendant/Non-Applicant No. 8 to suspend/block the access to Shiprocket Engage software provided to Defendant/Non-Applicant No.1 and provide complete details of the particulars of Defendant/Non-Applicant No.1 registered with Defendant/Non-Applicant No.8 to this Hon'ble Court and the Plaintiff/Applicant's Indian representatives;
- j) An order directing the Defendant/Non-Applicant Nos. 9 and 10 to issue a notification calling upon the Internet Service Providers and Mobile Network Operators registered under it to block access to the Defendant/Non-Applicant No. 1 's website and any other domain names discovered during the proceedings to have been engaging in or carrying out fraudulent activities by infringement of the Plaintiffs Mark:
- k) An order and decree directing the Defendant/Non-Applicant No. 11 to cancel the domain registrations of the Defendant/NonApplicant No. 1, and to provide contact details/addresses of the Defendant/Non-Applicant No.1 to this Hon'ble Court and the Plaintiff/ Applicant's Indian representatives;
- 1) Any other orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the present case."
- **20.** In the above circumstances, issue notice, returnable on 25th April, 2023 before the Court.

21. Reply be filed within four weeks with advance copy to learned Counsel for the plaintiffs, who may file rejoinder thereto, if any, within four weeks thereof.

22. Till the next date of hearing, there shall be *ad interim* directions in terms of prayers (a), (c), (d), (e), (f), (g), (h), (i) and (j) of the application as reproduced hereinabove.

23. Let the plaintiff comply with the requirement of Order XXXIX Rule 3 of the CPC within one week from today.
