**I.A. 4201/2023 (for exemption)**

1. Subject to the plaintiff filing the original, certified and true typed copies of the documents on which the plaintiff may seek to place reliance, within four weeks from today, exemption is granted for the present.
2. The application is disposed of.

**CS(COMM) 113/2023**

3. Let the plaint be registered as a suit.
4. Issue summons.
5. Summons are accepted by the counsel appearing on behalf of the

defendant no.34/Meta Platforms Inc.

6. Summons be issued to the defendants no.1 to 7 through email.

7. Summons be issued to the defendants no.27 to 33 and 35 to 37 through all modes. The summons shall state that the written statement(s) shall be filed by the defendants within thirty days from the date of the receipt of summons. Along with the written statement(s), the defendants shall also file affidavit of admission/denial of the documents of the plaintiff, without which the written statement(s) shall not be taken on record.

8. Liberty is given to the plaintiff to file replication(s), if any, within thirty days from the receipt of the written statement(s). Along with the replication(s) filed by the plaintiff, affidavit of admission/denial of the documents of the defendants be filed by the plaintiff.

9. The parties shall file all original documents in support of their respective claims along with their respective pleadings. In case parties are placing reliance on a document, which is not in their power and possession, its detail and source shall be mentioned in the list of reliance, which shall also be filed with the pleadings.

10. If any of the parties wish to seek inspection of any documents, the same shall be sought and given within the timelines.

11. List before the Joint Registrar on 21<sup>st</sup> April, 2023 for completion of service and pleadings.

12. List before the Court on 22<sup>nd</sup> May, 2023.

13. The plaintiff is permitted to approach the Court with an application for impleadment and seeking necessary relief(s) in case any other website/domain/entity is discovered to be infringing the 'IFFCO' marks of the plaintiff and/or carrying out similar fraudulent activities.

**I.A. 4200/2023 (O-XXXIX R-1 & 2 of CPC)**

14. The present suit has been filed seeking permanent injunction restraining the defendants from infringing the trademarks of the plaintiff, passing off and other ancillary reliefs.

15. The plaintiff in the present suit is a multi-state Cooperative Society engaged in the business of manufacturing and marketing chemical fertilizers and other allied fields. It has been averred in the plaint that the plaintiff is



the registered proprietor of the trademarks 'IFFCO', and other 'IFFCO' formative marks in various Classes [hereinafter "IFFCO' marks"]. Details of the various trademark registrations in favour of the plaintiff are provided at pages 2 to 43 of the documents filed along with the plaint. The plaintiff has also placed on record a certificate of the Chartered Accountant reflecting the financial performance of the plaintiff in the last five years to demonstrate that the plaintiff has attained goodwill and reputation in the market. The annual turnover of the plaintiff for the financial year 2021–2022 alone is valued at approximately Rs.400,000,000,000/-.

16. The case set up by the plaintiff is that defendants no.1 to 7 are the registrants of fake, fraudulent and unauthorized domain names/rogue websites, which are being dishonestly used to mislead the general public into believing that the websites belong to/are associated with the plaintiff. The defendants no.8 to 15 are the account holders of the bank accounts associated with the websites of defendants no.1 to 7. Defendants no.27 to 32

are the domain name registrars of the fraudulent websites of defendants no.1 to 7. Defendants no.16 to 26 are the registrants of fake and fraudulent accounts/pages/groups on the social media platform Facebook. Defendant no.33 is Internet Corporation for Assigned Names and Numbers (ICANN). Defendant no.34 is Meta Platforms Inc. (multinational companies/owners of Facebook). Defendant no.35 is the Department of Telecommunications. Defendant no.36 is the Ministry of Electronics and Information Technology. Defendant no.37 is the National Internet Exchange of India. Defendant no.38 is the National Payments Corporation of India. Defendant no.39 is the Reserve Bank of India (RBI). Defendant no.40 i.e. “John Does” refer to all the registrants of such other unknown rogue websites, bank accounts and Facebook accounts/pages/groups.

17. It is submitted on behalf of the plaintiff that the rogue websites of the defendants no.1 to 7 have defrauded customers of their money under the guise of providing franchises/dealerships of the plaintiff Society. Attention of the Court has been drawn to the complaint received by the plaintiff Society in respect thereto as well as the compilation of complaints filed and FIRs registered against the defendants no.1 to 7.

18. Issue notice.

19. Notice is accepted by the counsel appearing on behalf of the defendant no.34/Meta Platforms Inc.

20. Notice be issued to the defendants no.1 to 7 through email.

21. Notice be issued to the Banks where the defendants no.8 to 15 hold accounts, as per the details given in the memo of parties, through all modes.

22. Notice be also issued to the defendants no.27 to 33 and 35 to 37 through all modes.

23. Reply(ies) be filed within four weeks.
24. Rejoinder thereto, if any, be filed within two weeks thereafter.
25. Based on the averments in the plaint and submissions made on behalf of the plaintiff, a *prima facie* case has been made out on behalf of the plaintiff. Balance of convenience is in favour of the plaintiff. Irreparable harm would be caused not only to the plaintiff but also to the public if an *ex-parte* ad interim injunction as sought is not granted in favour of the plaintiff.
26. Consequently, till the next date of hearing, an *ex-parte* ad interim injunction order is passed in the following terms:
- I. The defendants no.1 to 7 and their employees, servants, agents, representatives, assignees, through themselves and/or through assigns and/or representatives and/or all other servants, agents, acting for and on their behalf are restrained from using their respective domain names and websites in any manner whatsoever.
  - II. The defendants no.1 to 7 and their employees, servants, agents, representatives, assignees, through themselves and/or through assigns and/or representatives and/or all other servants, agents, acting for and on their behalf are restrained from registering any domain names/websites using the 'IFFCO' trademarks of the plaintiff in any manner whatsoever or any other marks which are identical or deceptively similar to the trademarks of the plaintiff.
  - III. The email addresses mentioned on the rogue websites of the defendants no.1 to 7 shall be de-activated by the defendants no.1 to 7.
  - IV. The Banks where the defendants no.8 to 15 hold accounts, as mentioned in the memo of parties, shall furnish to this Court the details of the account holders, their addresses, contact details, statements of

accounts.

- V. The aforesaid Banks where the defendants no.8 to 15 hold accounts are further directed to freeze the bank accounts as mentioned in the memo of parties.
- VI. The defendants no.35 and 36 shall issue directions to all ISPs to block the websites of the defendants no.1 to 7 as given in the memo of parties, except the websites of the plaintiff bearing the 'IFFCO' marks.
- VII. The defendants no.27 to 32 shall immediately suspend/block the domain names, as also the websites of the defendants no.1 to 7 as given in the memo of parties. Status quo shall also be maintained in respect of the said domain names and the same shall be locked with immediate effect.
- VIII. The defendants no.27 to 32 are also restrained from transferring the said domain names or creating any third-party interest in the same.
- IX. The defendants no.27 to 32 shall also disclose to the counsel for the plaintiff and file an affidavit before this Court providing the details of the registrations or the persons who have registered the abovementioned domain names along with their complete contact details, including postal address, email address, bank account details, telephone numbers and the like. Let the said affidavit be filed within one week from the receipt of the copy of this order. Upon receipt of this order, the defendants no.27 to 32 shall communicate immediately the order to the registrants of the infringing domain names.
- X. The defendant no.34 shall furnish to the Court the Basic Subscriber Information concerning defendants no.16 to 26 in electronic form, which shall be password protected, within one week from today. The

said information shall also be communicated to the counsel for the plaintiff within one week from today.

XI. The defendant no.34 is directed to suspend/block access to accounts/groups/pages as mentioned in paragraph 32 of the plaint within ten days.

27. Upon the disclosure of the names of the registrants of the domain names as aforesaid, the plaintiff is permitted to implead the registrants as defendants in the present suit. The plaintiff is also permitted to approach the Court with an application for appropriate relief, including seeking extension of the present injunction to any other website/domain/entity using the 'IFFCO' marks of the plaintiff.

28. Compliance under Order XXXIX Rule 3 of the Civil Procedure Code, 1908 (CPC) be done within five days.

29. List before the Joint Registrar on 21<sup>st</sup> April, 2023 for completion of service and pleadings.

30. List before the Court on 22<sup>nd</sup> May, 2023.
