(e.) Issue a direction to the Defendant No. 11 to secure blocking of the Web Pages/ URL(s)/ Listings of the impugned web-sites of Defendant No. 1 and/or mirror/redirect/alphanumeric websites, which are put in play by Defendant No. 1 and URLs [ as listed in Schedule A] and/or any other URLs which may come up in the future as and when reported to the Defendant No. 11 under affidavit filed by the Plaintiff in respect of impugned goods bearing impugned Trademarks/Labels HUGO BOSS, and its variants or any other word/mark/Trademark/Label which may be identical with and/or deceptively similar to the Plaintiff's said Trademark/Label/Trade Name HUGO BOSS, BOSS, HUGO and other BOSS/HUGO formative marks such as HUGO HUGO BOSS, BOSS HUGO.

(f.) Issue a direction to Defendant No. 12 to secure blocking of the Web Pages/URL(s)/ Listings of the impugned web-sites of Defendant No. 1 and/or mirror/redirect/alphanumeric websites, which are put in play by Defendant No. 1 URL(s) [as listed in Schedule A] and/or any other URLs which may come up in the future as and when reported to the Defendant No. 12 under affidavit filed by the Plaintiff in respect of impugned goods bearing impugned Trademarks/Labels HUGO BOSS, HUGO, BOSS and its variants or any other word/mark/Trademark/Label which may be identical with and/or deceptively similar to the Plaintiff's said Trademark/Label/Trade Name HUGO BOSS, BOSS, HUGO and other BOSS/HUGO formative marks such as HUGO HUGO BOSS, BOSS HUGO BOSS, HUGO BOSS, etc.

The counsel for plaintiff has relied upon the order dated 28.09.2021 passed by Hon'ble High Court of Delhi in CS (Comm.) No. 474/2021 entitled Loreal S.A. Vs. Ashok Kumar and Others in which the Hon'ble High Court had issued directions to the concerned

registrar to furnish details and particulars in respect of infringing website.

The counsel for plaintiff has relied upon order dated 25.10.2021 passed by Hon'ble High Court of Delhi in CS (COMM.) No. 524/2021, in which the Hon'ble High Court issued directions to the Department of Telecommunications and Ministry of Electronics and Information Technology.

As already held in the ad interim Order dated 16.03.2022, the plaintiff has made out a prima facie case. Accordingly, directions are issued to the respective domain name registrars and web hosting service providers in terms of prayer (d) of application to disclose the details and particulars of the ownership of the defendant no. 1's websites and/or mirror/redirect/alpha numeric websites including all details provided at the time of registration and payment details.

Directions are issued to the defendant no. 11 and 12 in terms of prayer (e) and (f) of the application.
