  - (I)(a) Holding analogous posts on regular basis in the parent cadre or Department; or
    - (b) Minimum two years of service in the Higher Administrative Grade (HAG) scale that is Rs. 67000-79000 with 3 per cent increment or equivalent rendered after appointment thereto on regular basis; and
  - (II) Possessing the following educational qualifications and experience:
  - (a) Master's Degree in Economics or Master of Commerce (M.Com) /Master of Business Administration (MBA) or Master's Degree in Business Administration with specialization in Finance from recognized University or Institution.

- (b) Members of the Institution of Chartered Accountancy or Institute of Cost and Works Accountants of India (ICWAI) or Institute of Chartered Financial Analysts of India (ICFAI).
- (III) Working experience of 20 years in Central or State Government, or in Organizations of Central or State Government, in the areas of Financial Planning, Programming, Budgeting, Operations, Accounting, Reporting or Auditing

**Note-1:** Officers working in Central or State or Union Territory Governments shall only be eligible for absorption.

- **Note-2**: Period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organizations or Department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding fifty six (56) years as on the closing date of receipt of applications.
