In consideration of the request of the following Service Providers, the undersigned is directed to convey approval of the competent authority for allotment of MSC codes as per details given below :



2. All the telecom service providers are requested to take necessary action for opening of the above codes in their network immediately.

3. As the license agreements of (a) M/s Unitech Wireless (Mumbai) Pvt. Ltd. for Mumbai LSA and (b) M/s Unitech Wireless (East) Pvt. Ltd for (UP(East) LSA have been quashed vide Hon'ble Supreme Court's Order dated 02.02.2012 and these directions shall become operative after 07th September, 2012, the above mentioned MSC Codes are being issued for operational purposes for limited period and till 07th September, 2012, without prejudice.

4. Also these MSC Codes are being issued without prejudice to action contemplated vide Show Cause Notice/Court Orders, if any/ any other action to (a) M/s Unitech Wireless (Mumbai)Pvt.Ltd. for Mumbai LSA and (b) M/s Unitech Wireless (East) Pvt. Ltd. for UP(East) LSA.

5. The allotment of MSC codes is without prejudice to any decision of the Deptt of Telecom in respect of request of companies for amalgamation of M/s. Unitech Wireless(Mumbai) Pvt Ltd and M/s. Unitech Wireless (East) Pvt Ltd into M/s.Unitech Wireless(Tamilnadu) Pvt Ltd.


