No. 138(E) dated 03.03.2014 by the Ministry of Personnel, Public Grievances and Pensions amending the Pension Rules.
- 4. The payment of arrears of pensionary benefits will be released by concerned CCA Offices to all CSO MTNL Retirees after due verification made in accordance with OM No. 42-04/2012-Pen(T) dated 28.04.2014.
