**Sub:- Termination/Revocation/Cancellation of Unified License (ISP Authorization) No. 821-234/2014-DS, Dated 11.03.2015, category-“C” for service Area “Chhapra SSA in Bihar” under condition of clause 10.2 (i) (Part-I) of Unified License Agreement.**

This is in pursuance to your reply received on dated 31.03.2022 to the Show Cause Notice issued on dated 06.01.2022 and its reminder dated 22.03.2022, inter-alia, accepting the default from your side.

2. More than 4 months have ended since the issue of show cause notice and 48 days have already passed since the date of reply of the show cause notice as such the licensee has been given enough time to comply with the terms and conditions of the license agreement. Licensee has still not complied with the License conditions.

3. In view of above, the Competent Authority has decided to terminate/revoke/cancel the Unified License (ISP Authorization) No. 821-234/2014-DS, Dated 11.03.2015, category-“C” for service Area “Chhapra SSA in Bihar” issued to you, under condition of clause 10.2(i) (Part-I) of Unified License Agreement. Accordingly, the said license is terminated/revoked/cancelled **w.e.f. 61st calendar day from the date of issue of this letter.**

4. As per condition 10.2(i) of the said Unified License Agreement, “*The Licensee shall be required to give a notice of at least 30 Calendar days to its customers within this period of revocation order*”. Therefore, it is requested to issue notice of at least 30 Calendar days to all your customers within 30 days from today.

5. The Bank Guarantee(s) submitted against the said license will be released under clause 11.2 (Part-I) of Unified License after ensuring clearance of dues.

6. As far as the dues of DS division are concerned there are no Non-Financial dues with regard to this licensee as on date. Further, DG T, WPC, LFP, WPF divisions are requested to ascertain their dues and issue "No Dues Certificate" or details of dues to O/O CGCA expeditiously.
