ORDER

In terms of Modified Assured Career Progression Scheme (MACPS) issued vide DOP&T's OM No.A.35034/3/2008-Estt.(D) dated 19.05.2009, and clarification issued vide OM of even number dated the 16<sup>th</sup> November, 2009, the following officials in LDC/UDC Grade of Department of Telecommunications are hereby granted financial upgradation under the MACPS in the Pay Scale and with effect from the date as mentioned against each :

2. The financial upgradation under the MACP Scheme shall be personal to the officials and shall have no relevance to their seniority position. As such, there shall be no additional financial upgradation for the senior official on the ground that junior official in the grade has got higher pay/grade pay under the MACPS.

3. Officials may exercise option under FR 22(1) a (i) within a period of one month from the date of issue of this order to get their pay fixed in the higher grade pay either from the date of their financial upgradation or from the date of their next increment viz. 1<sup>st</sup> July of the year. The pay and the date of increment would be fixed in accordance with clarification No.2 of Department of Expenditure's OM No.1/1/2008-IC dated 13.09.2008. the officials who are working in the higher grade on ad-hoc basis, may avail of the benefit of financial upgradation on reversion to the lower substantive post.

4. The financial benefits under the MACPS are subject to post audit and necessary recovery, if any, will be made in the light of audit objection.

5. The financial upgradation shall be strictly as per terms and conditions stipulated in the DOP&T's O.M. No.35034/3/2008-Estt.(D) dated 19.05.2009 and further amendments/clarification issued from time to time in this regard.
