To meet with the increased activities of DMRC in Rolling Stock Wing, we have an urgent requirement of filling up of JAG level officers (DGM level) at our Delhi, Mumbai and Vijayawada units. It is requested to circulate our requirement of filling up of 11 posts of DGM/Electrical/RS in DMRC on deputation.

**The eligibility criteria for the post of DGM/Electrical/RS as under:**

The officer should have experience of working in Electrical department. The officer should be working at JAG level/DGM level in grade Rs. 15600-39100-7600 Grade Pay (CDA)/29100-54500 (IDA). He should be clear from D&AR/Vigilance angle.

The candidates whose applications are forwarded by DoT will be screened by a Screening Committee consisting of three HoDs of DMRC. The candidate's suitability is decided, keeping in view the job requirement.

We shall be highly grateful if the names of willing officers for 11 posts of DGM/Electrical/RS are forwarded to us urgently in view of pressing need for Phase-III works of DMRC which is at a very advanced stage. The detailed check list for the above vacancy is enclosed. The selected officers will be eligible to draw parent department pay plus deputation allowance.


