Sir,

I am directed to refer to letter No. 269-2/2011-P.IV/LE (Vol.IV) (Pt.) (ii) dated 22.10.2019 on the subject noted above and to convey the approval of Competent Authority for issuing Presidential orders of 15 employees [1, 3 to 15, 18]-**Annexure I/authenticated by Sr. GM HR/A, MP Circle**, who were having TSM Status as on 30.09.2000 and regularised in BSNL on or after 01.10.2000 in terms of DTS letter's dated 29.09.2000, for their permanent absorption in BSNL w.e.f 01.10.2000 OR date of their regularisation, whichever is later. Remaining cases S.No. 2, 16 and 17 may be examined by the BSNL as per extant instructions on the subject.

2. However, before issuance of Presidential order, BSNL/Director (Estt.) nominated in MP Circle shall ensure that the concerned official is not facing disciplinary or criminal proceedings or is not under suspension. If any case is noticed against individual employee, his/her Presidential Order may not be issued at this stage. Decision in such case would be taken upon outcome of case only.
