The following information has been requested for under RTI, but no information has been received till dte.

Consequent on implementation of the Honourable CAT, Cuttack Bench order in OA NO.77/2012 US (SEA) had issued letter No.33-04/2016-SEA-III dated 16th June 2017 addressing CCA-Karnataka/Kerala/ Punjab/West Bengal to revert the UDCs wrongly absorbed as Sr. Accountant instead of Jr. Accountant.

In this connection, it is requested to furnish the following information under RTI Act 2005.

Text of RTI First Appeal (आरटीआई प्रथम अपील का पाठ): 1. The action taken by the above four circles and the number and names of the UDCs who were reverted along with copies of reversion orders. If not, the reasons for non compliance of the orders of DoT by the above circles may kindly be furnished.

- 2. The reasons for omitting the other circles though there are so many UDCs were wrongly absorbed as Sr. Accountant and continuing till date.
- 3. O/o Pr.CCA, AP Circle had informed the Director(SEA) vide its letter No.Pr.CCA/APC/Hyd/Sr.List/2015-16 dated 22nd September 2016(copy enclosed) that there are 7 Sr. Accountants(namely:PS Chakravarthy, SO, Delhi Transco Ltd, A PSU, M R Prabhakara Reddy and V Malathi both Assistants of CSS, CM Sarma, CI (Steno E), AS Ravi Kumar and Kumar Sashikanth both are SI (Ministerial) equivalent to UDC(copy of Establishment manual enclosed) T R Shyamala, an Assistant in GCS and 3 Jr. Accountants B Bikkoji and S Ramnath Data Entry Opertors M Rajendra Kumar, Steno from other than analogous posts were wrongly appointed. The reasons for not reverting them to the post of Jr. Accountant in case of 7 wrongly appointed Sr. Accountants consequent up on issue of order dated 16th June 2017 of US(SEA). The action taken on the wrongly appointed JAs may also be furnished.
- 4. Not only in AP Circle, in Tamil Nadu circle also there are 19 ineligible candidates wrongly absorbed out of 22 Sr. Accountants. The reasons for not reverting those ineligible candidates as the orders are to be uniformly applied to all circles across India.

Some Historical things

The background leading to such anomaly would show that the non-gazetted ministerial posts in CRPF were combatised on optional basis by an order dated 28.02.1981. The Applicant did not give his option for combatisation. The non-combatised staff continued to be called LDC, UDC, Head Clerk and Office Superintendent Equivalent ranks on combalisation became Assistant Sub-Inspector (Ministerial), Sub-Inspector (Ministerial), Inspector (Ministerial) and Subedar Major (Ministerial), respectively. Thereafter the promotion from both combatised as well as non-combatised sides was to the post of Administrative! Section Officer, Joint Assistant Director and Assistant Director. The OM dated 28.02.1981 issued by the first Respondent, Ministry of Home Affairs, also provided that the options once exercised would be final and those who did not opt for combatisation, would continue in civil posts until superannuation. Consequent upon implementation of the fourth Central Pay Commission (IV CPC) recommendations the combatised ministerial staff were granted the rank pay at par with the executive cadre by the first Respondent's letters dated 11.06 1987 and 16.03 1988 with effect from 1.01.1986. This benefit was not given to the non-combatised ministerial staff. Because of this, a difference in pay of combatised and non-combatised staff emerged, which is demonstrated by the table given below 5. The learned counsel for the Applicant has brought to our notice the memorandum submitted by the CRPF to the IV CPC, which, inter alia, stated that the combatised as well as the non-combatised staff were performing the same duties. This is not being disputed by the Respondents. Relevant part of the memorandum is reproduced below; (v) Ministerial Staff (Non Combatised) 156 Ministerial hands did not opt for combatisation and still continue to remain in the civil posts as before. They perform identical duties as are done by the combalised ministerial hands. We, therefore, recommend that their pay scales may be so revised as to bring the same at par with the pay scales to be adopted for their counterparts in the combatised Ministerial cadre on the principle of equal pay for equal work. 5.16 It is a fact that both the combatised and non-combatised ministerial stall constitutes a single cadre and are governed by the same set of Recruitment Rules. But the combatised ministerial staff has to wear uniform, put under basic training, bound to undergo musketry training and annual range classification firing. They are governed under CRPF Act and Rules. They have to maintain shape-1 medical category for gaining promotion. Non-Gazetted comunicad ministerial staff retire, on superannuation, at the age of 57 years whereas non-combatised M/ Staff (NGOs) retire at the age of 60 years. Rule 9 (31) (c) stipulates that the pay of an employee be determined with reference to his position in the cadre. The petitioner retained the non-combatised posts and therefore he has been allowed corresponding pay scales applicable to these posts/ positions. The applicant was promoted from the rank of Office Supdt (SOP of Rs. 5500-175-9000) to Adm Officer (SOP Rs 6500 200-10500) whereas reported junior was promoted from Subedar Major/ Ministerial (SOP of Rs. 6500-200-10500) to Adm Officer (SOP Rs. 6500-200-10500) and thus one of the conditions laid down for stepping up of pay that scales of pay of the lower and higher posts in which they are entitled to draw pay should be identical is not fulfilled and the petitioner is not entitled for stepping up of pay at par with the pay of reported junior i.e. Shri M.L. Yadav, AO and other. It is also vehemently denied that FR 9 (31) (c) would be applicable in the instant case. The learned counsel would contend that this would not apply because the Applicant and Shri M L. Yadav came from different pay scales to the post of Administrative Officer/Section Officer. 13. The learned counsel for the Applicant in his reply has strenuously urged that the Respondents have only undertaken a laboured exercise to show the difference between the combatised and non-combatised ministerial staff. He would contend that the reading of the Standing Order No 1/81 of 11.03.1981, already adverted to in the preceding paragraphs, would show that there is just a marginal difference of the combatised ministerial staff having to put uniform which they get free, washing allowance, ration money, free accommodation and enhanced EL. There is no difference in the work performed by combatised as well as non-combatised stream. The noncombalised ministerial staff also get posted to highly sensitive areas and undergo the same difficulties as the combatised staff in the performance of their duties.

In the newly created offices of CCA, there were no recruitments earlier. The recruitment took place during the period 2010-2011 as a one-time measure by transfer on absorption from eligible candidates. The recruitment was closed on 28/09/2011. The provisional concrety lists were published on 04/06/2012 and circulated among the candidates in the seniority lists. Several representations were received for revision of the list citing different rules/regulations/court judgments/constitutional provision etc. A committee was appointed in May 2013 who confirmed the same list on 01/07/2013 without giving any specific reasons for rejection of objections. This has resulted in several appeals. DoT also issued guidelines on 16/04/2013, 07/03/2014 and 05/08/2015 and directed to revise the seniority lists. For the purpose a committee has been appointed who submitted their report on 10/07/2015. The same has been discussed and the revised seniority lists are prepared giving clearly reasons/justifications for placing a particular candidate at a particular place citing the DoT orders and DoP&T orders.

The Recruitment took place during the period September 2010- September 2011 based on a single notification. The DoT Hqrs also issued guidelines for selecting the candidates at subsequent dates vide reference cited above at (2) and hence it is to be treated as a single recruitment for the purpose of fixation of seniority.

The seniority has been fixed by taking into consideration the length of service in the eligible grade i.e. the qualifying service in r/o UDC, LDC, JA and SA if any, date of deputation and date of absorption, whichever is earlier.

There are 15 UDCs absorbed from JS(Trg), M/o Defence. Their inter-seseniority of parent department is protected according their seniority in their parent cadre vide DOP&T instructions.

While fixing the seniority of absorbed candidates, it has been observed that 7 Senior Accountants and 3 Junior Accountants from other than analogous posts were considered and appointed four years back. Their appointment on absorption was not in conformity with the notification and the rules. However, it is felt that it is not appropriate at this stage to terminate or to repatriate to their parent departments as their lien with parent department would have been terminated 2 years after the absorption. Hence, it has been decided to fix their seniority after the names of eligible candidates. Accordingly the seniority has been fixed.
