

**Subject : Request for Information under RTI Act 2005 in continuation of my RTI  
Application dated.**

Sir,

I may kindly be provided with the following information in connection with P&T Accounts & Finance Service Group "A" (JTS). In reply to my application dated 12-07-17 for information under RTI act 2005, you have supplied the information vide your letter no.33-04/2016-SE-1 dt. 08-08-17

On study of the information supplied by you, some more doubts have come-up, therefore, it is requested to supply the information on the following points.

1. As per recruitment rules 2001, the post of JTS of Indian P&T Accounts & Finance Service Group "A" (JTS) filled up to 50% by direct recruitment and 50% by promotion of Sr.AO in Gr 'B'. But as per information supplied by you, The total sanctioned strength of JTS Gr. 'A' as on 06/03/2017 is 134, out of that 81 has been shown under direct quota and 53 post under promotion quota, while as per your order shown above it should be 50:50 i.e. 67 in each quota. I want to ascertain reasons of the discrepancy. Please supply copy of orders / note sheets under which the total 81 posts have been worked out to be justified under direct quota and 53 posts under promotion quota are justified.

2. Total vacancy under promotion quota has been shown as 24 out of this 2 SC and 2 ST posts were kept vacant. DPC held and UPSC had recommended the panel for promotion as detailed below:-

2016-17	=	13
2017-18	=	07 +1 (Reportedly Extended panel)
So, total vacancy	=	24
Post SC/ST kept vacant	=	4
Net posts	=	20

Thus, 20 posts should have been filled in by promoting the officers, but promotion order vide no.14-11/2016-sea-1dt. 23-06-17 have been issued only for 19 officers. I need to ascertain as to why 01 post have been kept vacant. Kindly supply Copy of orders / note sheets in this regard.

3. Out of promotion for 19 officer one name Ms poonmal D'souzawas ordered to be promoted w.e.f. 1-09-17. Kindly supply the name of officer against whom the reported vacancy has been filled in.

I am ready to pay prescribed fees for this purpose (cost of supply of documents) on hearing from you.

I am enclosing an IPO of Rs. 10/- (prescribed fees for RTI Application) bearing No.42F 327383 dated 08-09-17 issued by Post Master Central T. T. Nagar Bhopal.
