APPELLATE ORDER ON APPEAL DATED 13.09.2017 of SHRI. T.S.Krishnamurthy UNDER RTI ACT

I, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 13.09.2017 of Shri. T.S.Krishnamurthy filed before the First Appellate Authority..

Facts of the case:

1. The appellant filed the above first appeal before the First Appellate Authority on the ground that he has been provided with information on an entirely different issue other than the one asked for. i.e. fixation of remuneration to consultants appointed amongst ex-employees of MTNL. sought by him in his RTI application dated 27.04.2017.
2. The said RTI application dated 27.04.2017 had already been replied by Director(SEA)&CPIO vide letter No. 33-06/2017-SEA-I dated 04.07.2017.
3. In this regard the details of the documents sought for by the applicant/ appellant vide RTI application dated 27.04.2017 and in response, the Director(SEA)&CPIO supplied the documents vide letter dated 4.7.2017 to the applicant is as under:-

1.	Copy of the policy adopted by SEA branch of DoT with regard to fixation of "Remuneration to consultants appointed amongst the ex-employees of Mahanagar Telephone Nigam Limited, who retire while drawing Pay and Allowances under IDA Pay structure. (He also request you that the same may be provided to him together with copies of the internal notings and approvals obtained for finalizing such a 'Policy'".	The applicant was supplied the copies of internal notings of file No.3-2/2009-SEA-I of SEA section before finalisation of Policy of engagement of Consultants at DoT,(Hqrs ).

Decision of the appeal:

On perusal of reply given by Director(SEA)&CPIO vide letter dated 04.07.2017, it has been observed that complete parawise information has been furnished to the applicant.(in total of 8 pages which are enclosed again.) There is no misleading information or reply for a different issue other than the one asked for. As regards the contention that the "irrevelant information" w.r.t. whether BSNL/ MTNL retirees are to be appointed as consultant is concerned. it is observed that the same is not severable from the information sought by the Applicant/ Appellant. Further, no details as to how the information provided by the CPIO is incomplete, misleading has been submitted by the Appellant. As such, the action of the CPIO and reply given by the CPIO vide letter No. 33-06/2017-SEA-I dated 04.07.2017 is in order.

2. Accordingly, I dispose of the appeal dated 13.09.2017 of Shri T.S.Krishnamurthy
