

### Subject Information sought under RTI Act 2005.

This has reference to my RTI Dated 30.10.2017 and reply of CPIO dated 27.11.2017 (copy enclosed for ready reference).

In this context.the u/s would like to state the following

- 1. As per information furnished by the CPIO, the above Appeal has been transferred to another CPIO. CPIO has violated the Provisions of the above Act which expressly states that such transfer of Appeal should take place in not later than 5 days and applicant be informed immediately. That neither of the provisios have been adhered to clearly reveals, apart from violation of above RTI Act, the delay and diversionary tactics being pursued by CPIO.
- 2. As per information furnished by the CPIO, no Group A,B, or C officers have been posted till date in the O/O CGCA by the SEA Section, whereas for Personal staff and Group D staff, the application has been transferred to CPIO, NICF.

· Thus it construes from above information furnished by the CPIO, the SEA Section is responsible for posting of Group A,B,C Officers and NICF is responsible for posting of Group D and Personal staff.

As per order dated 28.04.17 enlosed along with reply of CPIO, NICF was to provide requisite administrative logistics for the day to day functioning of CGCA.

# APPELLATE ORDER ON APPEAL DATED 27.12.2017 FILED BY MS. SUMITA PURKAYASTHA

I, Saurabh K. Tiwari, the Appellate Authority in the Department of Telecommunications have carefully gone through the appeal dated 27.12.2017 filed by Ms. Sumita Purkayastha:-

### Facts of the case:-

- 1. Ms. Sumita Purkayastha sought the information under RTI Act, 2005 vide her application dated 30.10.2017.
- 2. The grounds of Appeal are as under :-
