It is replied stating that the information sought is query nature, but it is not query nature. the information provided is misleading, knowingly giving incorrect information. So only I made my first appeal here. Kindly examine the following and provide information under RTI Act please.

B. in case BSNL has approached DoT and got prior approval from their administrative Ministry i.e. Department of Telecom, copy of such approval may be provided please. Kindly verify the records available in DoT only and supply the copy if BSNL consulted and approval given or say NO BSNL not consulted.

C. in case BSNL has not approached their administrative ministry / department i.e. DoT and not get the prior approval, kindly intimate whether such amendments of RRs(which were continuing since 1977) are valid or not. Kindly verify the rules/records available in DoT and convey whether such amendments made by BSNL are Valid or not valid.

enclosed for ready reference), it is clear that

1. DPE (Department of Public enterprises) has not given any guidelines to the Board of CPSE BSNL to amend the Recruitment Rules of JAO (which were continuing since 1977) etc. (especially in the case of those who are absorbed from DoT to BSNL).

2. The Board of CPSEs are empowered to amend RRs, only in consultation with their administrative Ministry/Department. with this it is clear that BSNL might have got your prior approval for 1. preparing their own RRs for JAO Direct Recruitment 2. Preparing their own RRs for JAO LICE and for amending the RRs of JAOs (which were continuing since 1977) especially in Limited Internal Competitive Exam (LICE) case i.e. while changing the educational qualification, age etc.

3. As per RRs of LICE as on 30.09.2000 there is qualification of 10 plus 2/ intermediate to write JAO LICE. In JAO RR 2001 by BSNL the qualification is changed as Graduation for both 40% and 10% quota LICE. JAO LICE exam objective and 6 chances give to complete JAO part-II. Two chances are given in 2010 and 2012. Again they made amendments that a single exam will be conducted for JAO LICE. Of course, there is no problem regarding whether it is objective or descriptive, single or double. for their facility they have chosen as objective, single. But BSNL has to show the same status for both JAO part-I passed candidates (whether exam conducted by DoT or BSNL) as there is no change in syllabus. in contra, BSNL says those who pass in JAO part-I (conducted by DoT) they are eligible to write JAO single exam irrespective of their educational qualification, but those who pass in JAO part-I (conducted by BSNL) must have Graudation to write JAO single exam. how the logic applied is unknown. Another amendment made for both LICE exams 40% and 10% quota same exam will be conducted but the qualification for 40% quota it is Graduation and for 10% quota there is no minimum educational qualification (what logic it is). Like that without safeguarding / considering the interest of employees especially those absorbed from DoT i.e. from your Department.

APPELLATE AUTHORITY ORDER ON THE APPEAL OF SHRI K.R.L. SARMA DATED 13.3.2018 UNDER RTI ACT, 2005

An online RTI appeal No.DOTEL/A/2017/60044 dated 13.3.2018 from Shri K.R.L. Sarma has been received in this office on the ground that the CPIO has provided misleading information to his RTI application No.DOTEL/R/2018/500130 dated 12.2.2018.

- 2. In his RTI application the applicant had sought the following information:
 - Whether DoT has given any approval for preparing JAO RRs (which were (i) continuing since 1977 for absorbed personnel from DoT to BSNL) and the changes/amendments made in JAO RRs especially in case of JAO LICE eligibility conditions for absorbed employees. (YES/NO)
 - In case BSNL got prior approval from DoT, copy of such approval. (ii)
 - If BSNL has not approached DoT, whether such amendments of RRs are valid or not.
- I have gone through the appeal, the reply of CPIO and original RTI application and accordingly my observations are as follows:

In the appeal, the appellant has sought information, some of which are interrogatory in nature. Applicants may seek information only in respect of categories of information mentioned in section 2(f). Thus, the CPIO is not required to respond to such queries/questions under the RTI Act 2005. Further, there is no information available regarding the framing of RRs for the post of JAO in BSNL, with the Director (PSU-I) & CPIO.

- 4. In view of above, the appeal is disposed of.
- 5. In case the appellant is not satisfied, he may prefer a second appeal before the Chief Information Commissioner at the following address, within 90 days of receipt of this order:
