ORDER

At the time of regular promotion to this grade, the pay need not be fixed again for the officers who have been granted up-gradation under these orders. The officers may exercise their option for fixation of pay under relevant provision of FR-22(I)(a)(1) within one month from the date of issue of this order.
- 4. This order is being issued after obtaining the vigilance clearance from the Vigilance branch, DoT HQ. However, in case it comes to the notice of the Controlling Authority that any disciplinary/prosecution case is pending against the officer or the officer is under suspension, or any punishment of stoppage of increment etc is in operation against the officer, he should not be promoted without obtaining the specific approval of this Department. Information in this regard may be brought to the notice of the Department forthwith.
