**Subject: Re-distribution of posts of TES Group 'B' among different units of DoT**


Consequent to notification of Telecommunication Engineering Service (Group 'B') Recruitment Rules, 2019 vide Gazette notification GSR No. 146(E) dated 25.02.2019, and in continuation of restructuring of DoT field units aligning them with the License Service Areas of DoT, it has been decided to rationalize and redistribute the Group 'B' posts in various units of DoT.

2. Keeping in view the requirement of various units/ verticals, limited availability of posts at Group 'B' level and the strength of Group 'B' in the erstwhile TERM Cell(s) in the LSA, the no. of TES Group 'B' Posts in various units will henceforth be as under:
