

Checklist of the documents required for Surrender of ISP Authorization under Unified License

- (i) Application (format attached for ready reference) preferably on company letterhead under the signature of Authorized signatory to ADG (DS), Department of Telecommunications, Cabin No. 3, Hall No. 1012, Sanchar Bhawan, 20- Ashoka Road, New Delhi-110001.
- (ii) Board resolution regarding decision of the company to surrender the Unified License and ISP Authorization under relevant clauses of Unified License and detail of authorized signatory including name and designation along with the specimen signature.
- (iii) An Undertaking regarding advance notice of 30 days to the customers, if the service is in operation. (That the Company will inform/notify to the customers by sending 30 days' advance notice for closure of Internet Service)
- (iv) An Undertaking as per following format regarding deduction of revenue from Pure Internet services on company letterhead duly signed by authorized signatory of the company: -

"We are aware that the matter of deduction of Revenue from Pure Internet Services from AGR is subjudice in the Hon'ble Supreme Court vide CA 220/2021. Further Hon'ble Supreme Court in its order dated 05/01/2021 has stated that "The respondents shall, in the event the appeal succeeds, be subject to such final directions as may be passed by the court in its judgment ". Accordingly, we hereby undertake that we will abide by the final directions of Hon'ble Supreme Court in CA 220/2021.
