

**ORDER**

In continuation of this Department's order No.14-8/2015-PSA dated 04.01.2018, the approval of Appointment Committee of the Cabinet (ACC) conveyed vide their communication no.24/3/2017-EO (ACC) dated 19.01.2018 in response to DoT's communications No.14-6/2016-PSA (Vol.II) dated 15.12.2017 and No.14-8/2015-PSA(Pt.I) dated 17.08.2017 is as follow:-

- (i) appointment of Shri S. Gopu, Director (HR), Indian Telephone Industry Limited (ITI) to the post of Chairman and Managing Director (CMD), ITI in the scale of pay of Rs.27,750-750-31,500/- (pre-revised) for a period w.e.f. the date of his assumption of charge of the post and till 31.05.2018 i.e. the date of his superannuation, or until further orders, whichever is the earlier.
- (ii) extension of the additional charge of the post of CMD, ITI in favour of Shri S. Gopu, Director (HR), ITI w.e.f. 01.10.2017 till he assumes regular charge of the post or until further orders, whichever is earlier.

2. The detailed terms and conditions of appointment of Shri S. Gopu as CMD, ITI Ltd. will be governed as per DPE guidelines on the subject and are being issued separately.
