Office Memorandum

Subject: Implementation of Numbering Resource Management System (NRMS) module in Saral Sanchal Portal.

The allocation and management of numbering resources is governed by National Numbering Plan-2003 as amended from time to time and other applicable guidelines issued by DoT. In order to efficiently manage allocation of numbering resources, it has been decided to introduce a new online module i.e. Numbering Resource Management System (NRMS) in Saral Sanchar Portal. Implementation of NRMS module is a further step towards Enabling Ease of Doing Business and Reduction in Compliance Burden.

2. The salient features of NRMS module include:

- a. Online application using Digital Signature of the Authorized Signatory of the Licensee (s) for allocation of the numbering resources.
- b. Automatic routing of application to concerned LSA or DoT HQ as per the extant guidelines.
- c. Automatic work flow management for verification by LSAs as applicable.
- d. Online generation and submission of certificates by LSAs for processing of the request by DoT HQ.
- e. Allocation of numbering resources by DoT HQ.
- f. Online submission of yearly/ periodic reports by Licensee(s) regarding utilization of numbering resources as per the extant policy and guidelines.
- g. Withdrawal or surrender of non-utilized or underutilized numbering resources as per the extant policy and guidelines.
- h. Centralized reference database for different numbering resource.

3. Now, MSC codes, wire-line codes and M2M codes shall be allocated through NRMS module to Licensee (s). Accordingly, all the Licensee (s) shall apply for MSC codes, wire-line codes and M2M codes through NRMS module only from the date of launch of NRMS module.

4. The user manual for allocation of MSC codes, wire-line codes and M2M codes is available for ready reference as a part of NRMS module. The access of NRMS module will be available to the eligible Licensees through their existing Saral Sanchar credentials. Any Licensee, to whom the License has been issued prior to introduction of Saral Sanchar portal, shall immediately apply on Saral Sanchar portal for migration. 5. NRMS module will go live w.e.f. **01.02.2023**.
