**Sub: - Termination/Revocation/Cancellation of UL(ISP) Category 'B' license no. 821-313/2015-DS dated 01.09.2015 for Rajasthan Service Area of M/s DNS Infonet Pvt Ltd, under condition of clause 10.2 (i) (Part-I) of the License Agreement.**

In respect of your reply dated 18.06.2023 to the Show Cause Notice dated **23.05.2023** it is seen that you have not complied with the following violations mentioned in the show cause notice.

a) Licensee has failed to pay license fee on self assessment basis and submission of annual audited documents for FY 2020-21, 2021-22 and FY 2022-23.

b) You have still not replenished the encashed Bank Guarantees (FBG and PBG)

2. It may also be noted that the interim order dated 01.07.19 passed in TP 47/2019 is linked to realization of demand for license fee raised up to FY 2018-19 only and not covers the violations mentioned in para 1 above .

3. As such, the competent Authority has decided to terminate/revoke/cancel the **category UL(ISP) Category 'B' license no.821-313/2015-DS dated 01.09.2015 for Rajasthan Service Area of M/s DNS Infonet Pvt Ltd, under condition of clause 10.2 (i) (Part-I) of the License Agreement.** Accordingly, the said license is terminated/revoked/cancelled **w.e.f. 61st calendar day from the date of issue of this letter.** You are directed to terminate and stop all interconnections with all service providers w.e.f. the date of termination of this License / Authorization.

4. As per condition 10.2(i) of the said Unified License Agreement, *The Licensee shall be required to give a notice of at least 30 Calendar days to its customers within this period of revocation order*". Therefore, it is requested to issue

notice of at least 30 Calendar days to all your customers within 30 days from today.

5. It may be noted that if any other violation of license conditions is reported against you then necessary action i.r.o said violation may be initiated in due course of time. The Bank Guarantee(s) submitted against the said license will be released under clause 11.2 (Part-I) of Unified License after ensuring clearance of dues including dues/penalty arising, if any, as a consequence of the aforesaid violation.

6. As far as the dues of DS division are concerned the same shall be intimated in due course of time to O/o CGCA. Further, DG(T), WPC, Concerned CCA, WPF divisions are requested to ascertain their dues and issue "No Dues Certificate" / details of dues to O/O CGCA expeditiously..
