Sub: - Termination/Revocation/Cancellation of UL(ISP) Category 'C' license no. DS-11/58/2015-DS-III dated 28.04.2016 for Kangra, Hamirpur, Mandi and Solan SSA's in Himanchal Pradesh Service Area of M/s Nitya Internet Pvt Ltd, under condition of clause 10.2 (i) (Part-I) of the License Agreement

In respect of no reply received from you to the Show Cause Notice issued dated **28.05.2023** and it is noted that you have not complied with the financial conditions of the License as stated in the said show cause notice and it is understood that you have nothing to say about the said show cause notice.

2. As such, the competent Authority has decided to treat the DOT letter **No. DS-11/58/2015-DS-III dated 22-05-2023 regarding acceptance of surrender of category UL(ISP) Category 'C' license no. DS-11/58/2015-DS-III dated 28.04.2016 for Kangra, Hamirpur, Mandi and Solan SSA's in Himanchal Pradesh Service Area of M/s Nitya Internet Pvt Ltd, as letter for termination.**

3. **This is under condition of clause 10.2 (i) (Part-I) of the License Agreement.** Accordingly, the said license is terminated/revoked/cancelled DOT letter **No. DS-11/58/2015-DS-III dated 22-05-2023.** You are directed to terminate and stop all interconnections with all service providers w.e.f. the said date of termination of this License / Authorization.

4. It may be noted that if any other violation of license conditions is reported against you then necessary action i.r.o said violation may be initiated in due course of time. The Bank Guarantee(s) submitted against the said license will be released under clause 11.2 (Part-I) of Unified License after ensuring clearance of dues including dues/penalty arising, if any, as a consequence of the aforesaid violation.

5. As far as the dues of DS division are concerned the same shall be intimated in due course of time to O/o CGCA. Further, DG(T), WPC, Concerned CCA, WPF divisions are requested to ascertain their dues and issue "No Dues Certificate" / details of dues to O/O CGCA expeditiously.
