Sub:- Termination/Revocation/Cancellation of Internet services license Category 'B' license no. 820-1087/10-LR dated 02.06.2010 for Karnataka Service Area of M/s Seans Media Pvt Ltd., under condition of clause 10.2 (i) (Part-I) of the License Agreement.

In respect of no reply received from you to the Show Cause Notice issued on dated 21.03.2023 and its reminder dated 25.04.2023, it is noted that you have not complied with the Financial conditions of the License as stated in the said show cause notice dated 25.04.23 and it is understood that you have nothing to say about the said show cause notice.

2. As such, the competent Authority has decided to terminate/revoke/cancel the **category Internet services license Category 'B' license no. 820-1087/10-LR dated 02.06.2010 for Karnataka Service Area of M/s Seans Media Pvt Ltd., under condition of clause 10.2 (i) (Part-I) of the License Agreement.** Accordingly, the said license is terminated/revoked/cancelled **w.e.f. 61st calendar day from the date of issue of this letter.** You are directed to terminate and stop all interconnections with all service providers w.e.f. the date of termination of this License / Authorization.

3. The Bank Guarantee(s) submitted against the said license, if not already encashed, will be released under clause 11.2 (Part-I) of Unified License after ensuring clearance of dues.

4. As far other dues of DS division are concerned there are no Non-Financial dues with regard to this licensee as on date. Further, DG T, WPC, Concerned CCA, WPF divisions are requested to ascertain their dues and issue "No Dues Certificate" or details of dues to O/O CGCA expeditiously.
