TRAINING CIRCULAR

Subject:- Knowledge Co-Creation Program on “**Improving ICT Policy Planning Skills Utilizing Standards**” – The deployment of better ICT Infrastructure to overcome challenges in Japan from 20th January to 6th February, 2016.

The Government of Japan has invited nominations for the above mentioned training programme to be held in Japan under the Technical Cooperation Programme with India. The programme is intended for Government officers in charge of telecommunications administration or department of telecommunications who is in charge of standardization of telecommunications. The eligibility conditions and other information about the course are mentioned in the Information Booklet received from the sponsoring Government (**Annex-I**). Number of slots available for India is **one**. In addition, name of the one “reserve” candidate may also be forwarded.

2. Nomination of candidates is regulated by the guidelines prescribed by DEA, as synopsis of which is attached as **Annex-II**.

3. **The course is fully funded** and the Government of Japan will provide round-trip air fare, accommodation and living allowance.

4. The following forms need to be duly completed and certified by the participant and the competent authority in the nominating Ministry/Department, as required under various columns.

- (i) Prescribed application form together with the medical history questionnaire.
- (ii) DEA's prescribed proforma - duly countersigned by competent authority (**Annex-III**).
- (iii) The desired Country Report (Two copies).
