- 3 . All ITS Group A and TES Group B officers are hereby directed to enroll for the iGoT portal and complete minimum of two courses available on iGOT, before 3lst Jan 2023. Further, all officers must comply the instructions issued time to time by NTIPRIT without fail. Further, it may please be noted that APAR of 2023-24 would be evaluated on the basis of assessment of their performance in iGoT training modules. Undertaking MKY courses and active participation in immersion program etc., may be made one of the work items to be reviewed/reported upon by the reporting officer in the APAR. The concerned reporting officers may lay down target for completion of mandatory courses for their team members for the year 2022-23 and 2023-24 based on the Annual Capacity Building Plan(ACBP) being prepared.

This is in reference with the Minutes of SMG meeting issued vide OM dated 21.11.2022.
 Vide para 3. (iii) of SMG which inter alia mentioned that "A circular may be issued that APAR of 2023-24 would be evaluated on the basis of assessment of their performance in iGOT training modules".

2. Government of India has launched Mission Karmayogi, a National Programme for Civil Services Capacity Building (NPCSCP) in September 2020. The programme aims at building a future-ready civil service with the right attitude, skills and knowledge, aligned to the vision of New India. It also aims to prepare Indian Civil Servants for the future by making them more creative, constructive, imaginative, proactive, innovative, progressive, professional, energetic, transparent, and technology-enabled.

The Mission envisages a comprehensive reform of the capacity building which will be delivered through **iGOT Karmayogi** Digital Platform. It is an Integrated Government Online Training digital platform under the Ministry of Human Resources and Development (MHRD). which will deliver capacity building programmes by drawing content from global best practices rooted in Indian national ethos. Civil servants will have to take online courses and they will be evaluated based on their courses, their performances in each course.

 iGOT Karmayogi platform presently hosts around 300 courses under various broad themes such as Public administration, E-Governance, Public procurement process, GeM, Information & Communication Technology, Economics, Digital Governance, Law, Management and Emerging technologies etc.

- 4. In this regard, CB&T Division has issued OM no. 53-1/2022/MK-Trg dated 05.12.2022 (copy enclosed), and encouraged officers to enrol and take up the courses available of the iGOT platform to augment their existing skillset.

- 2. iGoT portal, presently under evolution phase, will eventually evolve into a full-fledged learning and knowledge sharing platform having world class training contents. However, it has been observed that several, very useful training courses has already been hosted on iGoT portal.
