**OFFICE ORDER No. 9 of 2008**

Subject :- Allocation of work to JS(T).

With the approval of competent authority, it has been decided that the following work will be allocated to JS(T):

- 1.(i) Administration of TRAI Act and other administrative matters relating to TRAI and TDSAT. All correspondence to TRAI on recommendation will be routed through JS(T)
- (ii) Telecom Commission Secretariat, National Telecom Policy, all matters relating to DOT restructuring other than those specifically allotted to other Wings.
- (iii) Rural Telephony and Convergence issues.
- (iv) Matters relating to FDI.
- (v) Investment promotion
- (vi) All Broadband matters.
- (vii) Board level appointments in PSUs.
- (viii) WTO matters relating to Multilateral Bodies dealing with Telecommunications.
- (ix) Telecom Centres of Excellence.
- (x) Telecom-2008 Conference
- (xi) All administrative and operational matters relating to BSNL and MTNL
- (xii) Auction of 3G and Wi-Max Spectrum(Wireless Division will assist).

The following officers will report to JS(T) :

- (i) DS(PSA) on Public Sector Undertakings, Board level appointments, and absorption matters of Group 'A' officers.
  - (ii) Director(T) who will report to him in relation to policy matters as well as broad band, Wi-Max, Rural telephony etc.
  - (iii) DS(TC) who will report on matters relating to telecom services in North East and administrative matters relating to TRAI and TDSAT.
  - (iv) Dir(SU-I) who will report to him relating to all administrative and operational matters of BSNL and MTNL.
2. It has also been decided that Director SU-I will report to JS(T) to handle the matters relating to BSNL/MTNL now allocated to JS(T). The nomenclature of Dir. (SU-I) will be Director(PSU).
  3. DDG(SU) will now handle the operational matter of PSUs other than BSNL/MTNL under DoT supported by Director (SU-II) who will be designated as Director(SU) only.

4. The matters relating to SR Division i.e. staff matters, trade union and SC/ST matters which is at present with DDG(PG) will now be transferred to DDG(SU) alongwith the staff dealing with the matter.
