Sub : Bifurcation of pension work between Pr. CCA Kolkata & CCA West Bengal - 1st Amendment to the procedure laid down as per SWS for disbursement of pension through PSU Banks-Reg.

The issue regarding bifurcation of pension payment work between Principal CCA Kolkata and CCA West Bengal has been under consideration. To streamline the procedure, the 1st amendment to the procedure laid down for disbursement of pension through Public Sector Bank is hereby issued and may be read as under-

*"Consequent upon the decision taken by the Competent Authority in Department of Telecommunications to merge the pension audit functions of both Kolkata & West Bengal Circles, Annexure-A stands amended to the effect that the territorial jurisdiction of office of Pr. CCA Kolkata (Sl.No.14 of Annexure-A) shall cover the whole State of West Bengal and Sikkim. No PPO shall be issued by CCA, W. Bengal to any CPPC of any PSU Banks w.e.f.01.11.2013 as the audit jurisdiction of both the circles have been merged. Pr. CCA Kolkata shall be responsible to forward all the PPOs of both the Circles to the CPPCs and other pension disbursing authorities w.e.f. 01-11-2013. However, the authorized signature of CCA West Bengal shall remain in use as settlement of retirement benefits in respect of offices as handled by CCA West Bengal shall continue. PPOs prepared by o/o CCA, W. Bengal shall be countersigned by the authorized counter signing authority of o/o Pr.CCA Kolkata. The CPPCs of the banks disbursing pension in the state of W. Bengal and Sikkim shall forward their scrolls to the % Pr.CCA, Kolkata w.e.f. 01-11-2013 both in hard copy and soft copy as per the prescribed standard format."*
