Dear colleagues,

You are all aware that unprecedented floods have caused havoc in the State of Jammu and Kashmir. A large number of persons have died or have been temporarily displaced. Property and infrastructure worth crores of rupees have been damaged. In such moments often many people including Govt / PSU officers / employees or their associations want to assist by way of financial contribution but don't know how to do it. One such way is by giving contribution in the Prime Minister's National Relief Fund (PMNRF). The contributions to the PMNRF have been notified for 100% deduction from taxable income under Section 80(G) of the Income Tax Act. Kindly bring it to the notice of all your services associations / officers / employees so that who so ever wishes to make a voluntary contribution knows about these provisions. In some cases officers / employees want that their contribution, like a fixed amount or one day salary etc. may be deducted from their salary and be paid to the Prime Minister's National Relief Fund. In such cases, you may make arrangements for the same as well as a system of depositing the amount so collected in the PM's relief fund in the name of individual officers / employees and ensure that the receipt is got issued in the name of individual, employees from the PMNRF so that the officer / employee can get income tax benefit.
