## Office Memorandum

Subject: Submission of Annual Immovable Property Return (AIPR) for the year 2021 by the Officers of IRRS Group-A & Group-B of Department of Telecommunications – regarding.

In accordance with the provisions of Rule 18(1)(ii) of CCS (Conduct) Rules, 1964, every Government servant belonging to any service or holding a Group-A or Group-B shall have to submit Annual Immovable Property Return in such form as prescribed by the Government giving full particulars regarding the Immovable Property inherited by him/her or owned or acquired by him/her on lease or mortgage either in his/her name or in the name of any member of his/her family or in the name of any other person dependent on him/her. The AIPR is to be submitted as on first January of every year in respect of the preceding year.

- 2. Further, attention is drawn towards DOP&T OM No. 11012/11/2007-Estt.A dated 27.09.2011 which stipulates that the officer who do not submit the property return by the prescribed time/date, would be denied vigilance clearance and will not be considered for promotion and empanelment for senior level posts in Government of India.
- 3. Accordingly, all the officers of IRRS Group-A & Group-B working in DOT HQ/WMO/WMS/RLO have to submit the above return by 31.01.2022. A Nil return may invariably be submitted even if the information regarding the property is Nil. While furnishing the information in the AIPR, use of the phrase such as "same as previous year" or "no change" is to be avoided. It may be noted that no further reminder in this regard shall be issued and officer will be liable for departmental action for violation of Rule 18(2) of CCS (Conduct) Rules, 1964 for non-submission of his/her AIPR.
- 4 . All the officers of IRRS Group-A working in DOT(HQ)/RLO and WMO/WM shall submit their AIPR for the year 2021 by 31.01.2022 through SPARROW portal only and no ink signed/physical copy is to be sent to this office.
- 5 . The AIPRs of IRRS Group-B officers (Junior Wireless Officers) who are
