As per OM NO. 2(9)/2000-DPE(WC)-GL-III/08 dated 23.04.2008 received from
Ministry of Heavy Industries & Public Enterprises, Department of Public Enterprises,
New Delhi, the DA payable to the executives of PSEs shall stand modified as follows:



These rates would be made applicable in the case of IDA employees whose pay
have been revised w. e. f. 1-1-97 as per DPE OM dated 25.6.1999 on the following lines:

- (a) In case of CPSEs who have not allowed the benefits of merger of 50% of DA
with basic pay as contained in DPE OM dated 26.02.2008 to their
employees, the DA payable shall be enhanced from the existing rates of
78.6% to 79.4% w.e.f. 01.04.2008.
- (b) In case of CPSEs who have allowed the benefits of merger of 50% of DA
with basic pay as contained in DPE OM dated 26.02.2008 to their
employees, the DA payable shall be enhanced from the existing rates of
28.6% to 29.4% w.e.f. 01.04.2008.


