We write with reference Letter F. No. AS-21/3/2017-AS-V-Part-1 dated 26.07.2018 & 08.08.2018, vide which the DoT had approved the merger of Vodafone India Limited (VIL) and Vodafone Mobile Services Limited (VMSL) with Idea Cellular Limited

This is to now inform you that **Vodafone India Limited (VIL)** and **Vodafone Mobile Services Limited (VMSL)** stand amalgamated with **Idea Cellular Limited** pursuant to a composite scheme of amalgamation and arrangement approved by the Ahmedabad Bench and Mumbai Bench of the Hon'ble National Company Law Tribunal (NCLT) vide their respective orders dated January 11, 2018 and December 21, 2017 (pronounced on January 19, 2018). Further the NCLT Mumbai has passed order on 30<sup>th</sup> August, 2018 for dissolution of VIL and VMSL which have been filed with the concerned Registrar of Companies on 31<sup>st</sup> August, 2018 and consequently the said VMSL and VIL stand dissolved and amalgamated with Idea Cellular Limited with effect from 31<sup>st</sup> August, 2018.

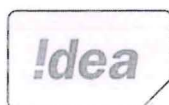
