- 1. This hearing has been done through hybrid mode.
- 2. Vide order dated 31st May, 2023, this Court had directed immediate action against various Domain Name Registrars (DNRs) to be taken by DOT and MeitY in the following terms:
 - "1. Pursuant to the order dated on 28th April, 2023 passed by this Court, an affidavit has been filed on behalf of defendant no.16, Ministry of Electronics and Information Technology, giving complete background of orders passed in connected suit with regard to blocking of non-compliant DNRs. Paragraph 12 of the aforesaid affidavit states as under:
 - "12. That, in view of the above, it is submitted that this Answering Defendant shall take similar

action of blocking of websites against the noncompliant DNRs in the present suit pursuant to a direction by this Hon'ble High Court. Such directions shall be immediately acted upon, including in terms of rule 10 of the Information Technology (Procedure and Safeguards for Blocking for Access of Information by Public) Rules, 2009...."

- 2. Counsel for the plaintiff submits that defendants no. 11 to 14 and defendants no.26 to 28 are foreign DNRs who have failed to comply with the repeated directions passed by this Court on 7th January, 2022, 24th January, 2022, 11th February, 2022 and 3rd June, 2022.
- 3. Therefore, in accordance with the directions passed by this Court on 9th November, 2022 in CS(COMM) 567/2022, the defendant no. 15, Department of Telecommunication (DoT) and the defendant no. 16, Ministry of Electronics and Information Technology (MeitY) respectively are directed to immediately take action within two weeks against the following DNRs for non-compliance of the orders passed by this Court:

- 4. Status report as to the action taken by defendants no.15 and 16 in respect of these DNRs be filed at least one week before the next date of hearing.
- 5. List before the Joint Registrar on 31st July, 2023."
- 3. Today, ld. counsel for the Plaintiff submits that blocking orders were initially issued by DOT and these DNRs were blocked from offering their services. However, the said blocking order does not appear to be in force currently. The websites are accessible and are offering their services to Indian customers.
- 4. A copy of the e-mail has been sent to the ld. CGSC, which states that currently these DNRs, against whom action was directed to be taken by this Court, are offering their services in India. The matter is extremely serious. In these cases, it is seen that repeated orders have been passed by this Court as also Coordinate Benches directing take down and blocking of various domain names which are infringing upon rights of IP owners. In a large number of cases, it is also noticed that these websites which are illegally registered by unknown persons are also used for duping Indian consumers and users from substantial amounts of money. It is under these circumstances that these orders are passed which the DNRs are expected to give effect to. If the DNRs do not abide by the orders passed by this Court, it is only then that an order such as the above one dated 31st May, 2023 has been passed.

5. Let a compliance affidavit be filed by DOT and MeitY as to what steps were taken pursuant to order dated 31st May, 2023 and under what circumstances were the blocking ordered initially and has the blocking been removed/withdrawn.

6. The names of the concerned officials who issued such orders shall also be placed before the Court inasmuch as non-implementation of orders passed by Indian Courts and Indian authorities can have a deleterious impact on law and order, on security as also enforcement of Court orders. Let the compliance affidavit be filed within two weeks.

7. List on 4th October, 2023.
