Trusted Dream! | logos, providing services similar to those provided by the plaintiff. The domain name www.trusteddream11.com as well as the aforesaid logos, it is submitted, infringe the plaintiff's registered trademarks.

- 5. This Court has, in several similar matters, protected the plaintiffs' registered trademarks against similar marks such as "Edream11", "Dream11Champ", "MyDream11", "FanDream11", "Dream7", "Sattadream11", "Dreamz11Sports", "Dreamz11", "Dream11apk.in", "Deep11", "ProDream11", "Dream11app.in" and "Dream111.net". Copies of the said orders have been placed on record.
- 6. The plaintiffs have, in these circumstances, approached this Court by means of the present plaint, seeking a permanent injunction against Defendant 1 as well as all other acting on its behalf, from using the marks "Trusteddream11"/ "Trusted pream11"/ "Trust
- 7. Let the plaint be registered as a suit.
- **8.** Issue summons in the suit. Summons are accepted on behalf of Defendants 3 and 4 by Mr. Harish Vaidyanthan.
- **9.** Let summons be issued to Defendants 1 and 2 at the email id indicated in the memo of parties.

- 10. - (ii) Defendant 2 is directed to disclose, on affidavit, the address and contact details of the registrant of the domain trusteddream11.com and to suspend and lock the said domain till the next date of hearing.
- (iii) Defendants 3 and 4 are directed to issue notifications requiring internet service providers to block access to the domain/website of Defendant 1 being <a href="https://www.trusteddream11.com">www.trusteddream11.com</a>.
- **17.** Compliance with Order XXXIX Rule 3 of the CPC, *qua* Defendants 1 and 2 be effected within a period of one week from today.
- **18.** Re-notify on 18 December 2023.

# I.A. 15264/2023 (under Section 12A of the Commercial Courts Act, 2015)

19. In view of the judgment of the Division Bench of this Court in *Chandra Kishore Chaurasia v. R.A. Perfumery Works Pvt Ltd*<sup>1</sup>, exemption is granted from the requirement of pre-institution mediation under Section 12A of the Commercial Courts Act, 2015.
