
**Subject:** Declaration of Assets and Liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 –filing of Returns by public servants - **Extension of last date** – regarding.

The undersigned is directed to refer to this Department's O.M. of even number dated 28<sup>th</sup> March, 2016 on the subject mentioned and to say that the last date for furnishing of declaration/information/annual return as on 01.08.2014 and 31.03.2015 relating to assets and liabilities by public servants under section 44 of the Lokpal and Lokayuktas Act, 2013 **has been extended upto 31.07.2016**. This would result in aligning the furnishing of all the three returns ( as on 01.08.2014, 31.03.2015 and 31.03.2016), on or before the 31<sup>st</sup> July, 2016. In this regard, a copy of Gazette Notification dated 11<sup>th</sup> April, 2016 is enclosed. Now the timelines for filing these returns are:-

- i. The first return of assets and liabilities **as on 1st August, 2014** under the Lokpal and Lokayuktas Act, 2013 - **on or before the 31st July, 2016**
- ii. The next annual return of assets and liabilities **as on 31st March, 2015** under the Lokpal and Lokayuktas Act, 2013 - **on or before the 31st July, 2016**.
- iii. The annual return of assets and liabilities **as on 31st March, 2016** under the Lokpal and Lokayuktas Act, 2013 should be filed **on or before 31st July, 2016**.
- iv. The annual return for subsequent years as on 31st March every year should be filed on or before 31st July of that year.

2. All Ministries/Departments and cadre authorities are requested to kindly issue order towards ensuring compliance of above timelines by all officers and staff in the respective Ministry/Department/Organizations/PSUs etc. under their control.

सा.का.नि. 414(अ).—केन्द्रीय सरकार, लोकपाल और लोकायुक्त अधिनियम, 2013 (2014 का 1) की धारा 59 की उपधारा (2) के खंड (ट) और खंड (ड) के साथ पठित धारा 44 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) नियम, 2014 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात् :—

1. (1) इन नियमों का संक्षिप्त नाम लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) संशोधन नियम, 2016 है।

(2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।

2. लोक सेवक (सूचना और आस्तियों तथा दायित्वों की वार्षिक विवरणी देने तथा विवरणियां फाइल करने में आस्तियों की छूट के लिए सीमाएं) नियम, 2014 के नियम 3 के उपनियम (2) में,—

(क) पहले परंतुक में "15 अप्रैल, 2016 को या उससे पूर्व" अंकों और शब्दों के स्थान पर, "31 जुलाई, 2016 को या उसके पूर्व" अंक और शब्द रखे जाएंगे;

(ख) दूसरे परंतुक में "15 अप्रैल, 2016 को या उससे पूर्व" अंकों और शब्दों के स्थान पर, "31 जुलाई, 2016 को या उसके पूर्व" अंक और शब्द रखे जाएंगे;

**NOTIFICATION**

**G.S.R. 414(E).**—In exercise of the powers conferred by sub-section (1) read with clause (k) and clause (m) of sub-section (2) of section 59 read with section 44 of the Lokpal and Lokayuktas Act, 2013 (1 of 2014), the Central Government hereby makes the following rules further to amend the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, namely:—

1. (1) These rules may be called the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Amendment Rules, 2016.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. In the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, in rule 3, in sub-rule (2),—
  - (a) in the first proviso, for the words and figures "on or before the 15th day of April, 2016", the words and figures "on or before the 31st day of July, 2016" shall be substituted;
  - (b) in the second proviso, for the words and figures "on or before the 15th day of April, 2016", the words and figures "on or before the 31st day of July, 2016" shall be substituted.
