**NOTIFICATION**

Sh. Mohana Rao M. (Staff No. 8529), an officer of Indian Telecom Services, Group 'A' officers has remained absent from duty without intimation/permission for more than 5 years, which tantamount to misconduct under CCS(CCA) Rules, 1965. In spite of repeated attempts to make contact, including a public Notice published in newspapers (Hindi/English), with Sh. Mohana Rao M., there has been no response on his part to contact the Authorities.

2. Now, therefore, in exercise of the power conferred under DoPT G.S.R. 261 (E) dated 29.03.2012 read with Rule 12(2) of CCS Leave Rules, 1972, which states that a Government servant who remains absent from duty for a continuous period exceeding five years other than on foreign service, with or without leave, shall be deemed to have resigned from the Government service: "Provided that a reasonable opportunity to explain the reasons for such absence shall be given to that Government servant before provisions of sub-rule (2) are invoked", the President of India has given consent to treat continuous absence of Sh. Mohana Rao M., as deemed resignation from Indian Telecom Services with effect from 13th November, 2018 under Rule 12(2) of CCS (Leave) Rules, 1972.

3. Sh. Mohana Rao M., shall not be entitled for any retirement benefits.
