Repatriation of DoT optees and absorption of BSNL optees

Sir,

I am directed to refer to the subject noted and to say that transfer and posting order of unabsorbed SDEs/JTOs/PA etc was issued by this office vide order dated 20-12-2017 (Copy enclosed). However, it was pointed out that list of unabsorbed employees provided by the BSNL contains the name of some BSNL optees or BSNL absorbed employees, who may not be repatriated to DoT HQ in terms of Sub Rule 6 of FR-37A. Several representations were received in the matter from officers concerned. Accordingly, above-mentioned order dated 20-12-2017 has been kept in abeyance vide order dated 28-02-2018. However, the employees who have joined LSAs have been allowed to work in LSA until further orders.

- Therefore, it is requested that the following information in respect of unabsorbed employees, as per list annexed, may be provided immediately to this office for examining the cases of repatriation of DoT optees and issue P.Os of BSNL optees, still working in BSNL:
- Attested copy of option exercised by the government servant for absorption in BSNL (i) w.e.f 01.10.2000 or revert to Government service;
- As to whether the above-mentioned option was accepted by the respective Circle; (ii)
- As to whether the Government servant/unabsorbed employee is facing any disciplinary proceeding or criminal proceedings;
- If answer to (iii) is yes, nature of case, issues/charges involved in the matter, present status of the case etc. may be furnished.
- Date of superannuation of Government servants (v)
- It may be ensured that the above-mentioned information in respect of employees 3. indicated in the list may reach to DoT by 28-03-2018. This may be provided Priority.


