Subject: Re-allocation of Short Code (166) and USSD code (*166#) to Department of Electronics & Information Technology, Government of India for m-Governance Services

In supersession of all earlier instructions regarding allocation of Short Code and USSD code to to Department of Electronics & Information Technology, Government of India, Approval of Competent Authority is hereby conveyed towards re-allocation of Short Code (166) and USSD code (*166#) to Department of Electronics & Information Technology for m-Governance Services. This re-allocation is to take into account 3GGP standards which allows only for two or three digits USSD codes only.

- 2. The features of Short Code (166) and USSD code (*166#) is as under:
 - (i) Category-I: Mandatory service to be provided by all the Access providers.
 - (ii) Un-restricted i.e., accessible from outside the SDCA also. This service shall be available without STD Code;
 - (iii) Metered and Calling Party Pays.
