

Subject:-Allocation of Short Code '1364' as Tourist Information Service Helpline to all State Govt. / UTs regarding.

In consideration of request of Uttar Pradesh Government vide letter No.2014 dated 17/11/2014, I am directed to convey the approval of competent authority for allocation of Short Code '1364' as Tourist Information Service Helpline to all State Govt./UTs with following features as under:

- (i) Category-I: Service (i.e. mandatory service to be provided by all the Access Service Providers.
 - (ii) Accessibility: Un-restricted i.e. available on STD also.
 - (iii) Metered Service: (It may be taken as Called Party Pays or Calling Party Pays depending on a separate intimation, to this effect, issued from the agency to which this short code is allocated in furtherance to this DoT instruction).
2. This allocation is made to have uniformity across the Nation. States /UTs may like to use the code for the intended purpose after making necessary arrangements with respect to required infrastructure.
3. All TERM Cells (field units of DoT) shall be nodal offices for co-ordination, required, if any, with Telecom Service Providers to implement the help line.
