1. This hearing has been done through hybrid mode.

I.A. 14789/2023 (for exemption)

2. This is an application seeking exemption from filing originals/ certified/ fair typed copies of dim/ proper margin/ underline/ single line spacing of the annexures.

3. Original documents shall be produced at the time of admission/denial, if sought, strictly as per the provisions of the Commercial Courts Act, 2015 and the Delhi High Court (Original Side) Rules, 2018.

4. Exemption is allowed, subject to all just exceptions.

5. Accordingly, application is disposed of.

I.A. 14787/2023 (u/S 12A of the Commercial Courts Act)

6. This is an application seeking exemption from instituting pre-litigation mediation. In view of the urgent orders which are being sought as also in view of the decision in *Chandra Kishore Chaurasia v. R A Perfumery Works Private Ltd, 2022/DHC/004454*, the application is

allowed and disposed of.

I.A. 14788/2023 (u/S 80(2) CPC)

7. This is an application filed by the Plaintiff, seeking exemption from serving a notice under Section 80 of the CPC.

8. Considering the urgency in this matter, exemption is allowed. Mr. Harish V. Shankar, Id. CGSC has been requested to accept notice.

9. Accordingly, application is disposed of.

I.A. 14786/2023 (u/S 61 of the Copyright Act, 1957)

10. This is an application seeking exemption from arraying the owner of the copyright under Section 61 of the Copyright Act, 1957.

11. In view of the facts of this case, the exemption is granted under Section 61(1) of the Copyright Act, 1957 from impleading the copyright owner i.e. the Olympic Council of Asia (OCA).

12. Application is disposed of.

CS(COMM) 542/2023

13. Let the plaint be registered as a suit.

14. Issue summons to the Defendants through all modes upon filing of Process Fee.

15. Summons are accepted by Mr. Harish V. Shankar, Id. CGSC on behalf of Defendant No. 146 - Ministry of Electronics and Information Technology, Union of India (*hereinafter, 'MeitY'*) and Defendant No. 147 - Department of Telecommunications, Ministry of Communications (*hereinafter, 'DoT'*).

16. The summons to the Defendants shall indicate that a written statement to the plaint shall be positively filed within 30 days from date of receipt of summons. Along with the written statement, the Defendants shall also file an

affidavit of admission/denial of the documents of the Plaintiff, without which the written statement shall not be taken on record.

17. Liberty is given to the Plaintiff to file a replication within 15 days of the receipt of the written statement(s). Along with the replication, if any, filed by the Plaintiff, an affidavit of admission/denial of documents of the Defendants, be filed by the Plaintiff, without which the replication shall not be taken on record. If any of the parties wish to seek inspection of any documents, the same shall be sought and given within the timelines.

18. Considering the large number of Defendants that have been impleaded in this matter, service by e-mail is permitted both by the Registry as also by the Plaintiff.

19. List before the Joint Registrar for marking of exhibits on 11th October, 2023.

20. List before Court on 12th January, 2024.

21. It is made clear that any party unjustifiably denying documents would be liable to be burdened with costs.

I.A. 14784/2023 (u/O XXXIX Rules 1 & 2 CPC)

22. The present petition has been filed by the Plaintiff - Culver Max Entertainment Private Limited seeking permanent injunction restraining the Defendants from infringing the Plaintiff's copyrights and broadcast reproduction rights.

23. The case of the Plaintiff is that it is a company incorporated in India. It was earlier known as Sony Pictures Networks India Pvt. Ltd. and has changed to its current name with effect from 20th April, 2022. The Plaintiff owns, operates and runs the Sony Sports Network of channels. The said channels include - SONY SPORTS TEN 1, SONY SPORTS TEN 1 HD,

SONY SPORTS TEN 2, SONY SPORTS TEN 2 HD, SONY SPORTS TEN 3, SONY SPORTS TEN 3 HD, SONY SPORTS TEN 4, SONY SPORTS TEN 4 HD, SONY SPORTS TEN 5, SONY SPORTS TEN 5 HD (*hereinafter 'Channels'*). In addition, the Plaintiff also runs the popular OTT platform under the name 'SONY LIV'. The said platform broadcasts content including films, web series, live sports and also showcases other events.

24. The present case relates to one of the Asia's biggest sporting events i.e., the 19th Asian Games, Hangzhou 2023 in China, (*hereinafter, 'Asian Games, 2023'*) scheduled to be held between 23rd September, 2023 to 8th October, 2023.

25. The case of the Plaintiff is that the OCA and the Plaintiff had entered into an agreement on 29th November, 2021 granting exclusive rights to broadcast and telecast the Asian Games, 2023 in the territories of India, Nepal, Pakistan, Afghanistan, Bhutan, Bangladesh, Sri Lanka and Maldives (*hereinafter 'territories'*). The said exclusive rights include rights to broadcast over television, mobile rights and radio rights both on a live, delayed and repeat basis (*hereinafter 'media rights'*) for the said territories. According to the Plaintiff, it has invested and paid a substantial sum of money to obtain media rights for the Asian Games 2023.

26. The Plaintiff avers that in view of the license given to it by the OCA, the content which is broadcasted, uploaded or telecasted by the Plaintiff exclusively belongs to the Plaintiff. The Plaintiff is the owner of the broadcast reproduction rights under Section 37 of the Copyright Act, 1957. Any illegal dissemination or unauthorized reproduction of the same would be violative of the said rights. Thus the Plaintiff is entitled to all remedies under Section 51 of the Copyright Act, 1957 just like any copyright owner.

27. Mr. Malhotra, Id. Counsel for the Plaintiff submits that the Defendants arrayed in the present suit fall in the following categories:

- (i) **Category I:** (Defendant Nos. 1 to 93) - Rogue Websites
- (ii) **Category II:** (Defendant Nos. 94 to 108) - Multi-System Operators (MSOs) and Local Cable Operators (LCOs)
- (iii) **Category III:** (Defendant Nos. 109 to 139) - Internet Service Providers (ISPs)
- (iv) **Category IV:** (Defendant Nos. 140-145) - Domain Name Registrars
- (v) **Category V:** (Defendant Nos. 146-147) - Department of Telecommunications and MeitY

28. Id. Counsel for the Plaintiff submits the Asian Games have a large viewership in the territories as stated above and hence there is a reasonable apprehension of piracy of the content and illegal distribution and communication of the content relating to the Asian Games.

29. It is a known fact that piracy and illegal dissemination of well-known sporting events is carried out not merely on traditional television platforms by MSOs and LCOs but also on the internet through rogue websites which are registered only for the purpose of carrying illegal content. There is therefore a need for reliefs against the Internet Service Providers (ISPs) to block the said rogue websites and for the domain name registrars (DNRs) of these rogue websites to lock and take down the said domain names in order to ensure that the dissemination of unauthorized distribution of the broadcast content of the Plaintiff is not permitted. It is submitted that MeitY and DoT are the appropriate bodies for issuance of orders for blocking of rogue websites and are therefore impleaded for the purpose of giving effect to the

orders that may be passed by this Court.

30. Issue notice.

31. Mr. Harish V. Shankar, Id. CGSC accepts notice on behalf of the DoT and MeitY.

32. The Plaintiff has placed on record screenshots of the various rogue websites which have been impleaded in this matter which show that these are live streaming websites illegally disseminating and broadcasting a large number of sporting events including World Aquatic Championship, Formula 3, National Rugby League, FIFA World Cup - Qatar 2022, Deodhar Trophy, Major League Cricket, Australian Women Cricket, World Championships, Belgium Pro League, etc. These websites are also advertising major fashion brands.

33. Ld. counsel for the Plaintiff relies upon similar orders that have been passed against the rogue websites and MCOs/LCOs. He also relies on the judgement of *Carlsberg Breweries A/S. v. Som Distilleries and Breweries Ltd.* AIR 2019 Del 23 (FB), *Iswar Bhai C. Patel alias Bachu Bhai Patel v. Harihar Behera and Another*, (1999) 3 SCC 457 as also the decision in *CS(COMM) 979 of 2018* titled *Sony Pictures Networks India Private Ltd. v. www.arenavision.in & Ors.* to submit that this is a case where joinder of causes of action ought to be permitted.

34. The Court has perused the aforementioned judgments. The relevant part of the said judgements is as under:

Carlsberg Breweries A/S. v. Som Distilleries and Breweries Ltd. AIR 2019 Del 23 (FB)

23. Order I Rule 3 prescribes that all persons may be joined as defendants in a suit against whom any right to relief exists provided that such right is based on the same

act or transaction or series of acts or transactions against those persons whether jointly, severally or in the alternative. Further, if separate suits were brought against such persons, common questions of law or fact would arise. The purpose of the Rule is to avoid multiplicity of suits. It is evident that this provision to some extent, also deals with the joinder of causes of action inasmuch as when the plaintiff frames the suit, he impleads persons as defendants against whom he claims to have a cause of action. Joinder of causes of action has been provided for in Order II Rule 3. These two provisions, i.e. Order I Rule 3 and Order II Rule 3, together, indicate that the question of joinder of parties also involves joinder of causes of action. The underlying principle is that if one is made a party to a suit because of a cause of action against him; when causes of action are joined, the parties too are joined. Parties to a suit may be necessary or proper parties. A necessary party is one whose presence is essential and against whom relief is sought. A necessary party also is one in whose absence, no effective decree can be passed. Conversely, a proper party is one without whom a decree can be passed and whose presence is not necessary for a complete adjudication of the dispute. Order I Rule 1 CPC requires joining of all persons in one suit against whom any right to relief arising out of the same act or transaction or series of acts is alleged to exist, jointly, severally, etc. and if such person brings several suits, common questions of fact or law arise. This provision deals with joinder of parties, and to a certain extent, with the joinder of causes of action. Order II Rule 3 CPC deals with joinder of causes of action. Order I Rule 4 of the Code too has to be read along with Order 1 Rule 1. It states that a judgment may be given without any amendment (a) for such one or more plaintiffs as may be found to be entitled to relief, for such relief as he or they may be entitled to; or (b) against such one or more defendants as may be found to be liable, according to their respective liabilities."

Iswar Bhai C. Patel vs. Harihar Behera and Ors.

(16.03.1999 - SC) : MANU/SC/0173/1999

12. *These two provisions, namely, Order 1 Rule 3 and Order 2 Rule 3 if read together indicate that the question of joinder of parties also involves the joinder of causes of action. The simple principle is that a person is made a party in a suit because there is a cause of action against him and when causes of action are joined, the parties are also joined.*

Sony Pictures Networks India Private Ltd. v. www.arenavision.in & Ors., CS(Comm) 979 of 2018

10. *In view of the submissions made in the plaint, application and supporting affidavits and documents, the fact that the plaintiff has exclusive media rights from ECB and OCA as detailed hereinbefore, a prima facie case is made out in favour of the plaintiff to have protection against the illegal transmission, broadcasting, communication, telecast and unauthorized distribution of any event, match, footage, clip, audio-video, audio only of India Tour of England scheduled to be held from 03.07.2018 till 11.09.2018 and 18th Asian Games, 2018 to be held from 18.08.2018 to 02.09.2018 in Jakarta and Palembang (Indonesia). Of course, the plaintiff, being the owner of the exclusive broadcast/media rights as granted to them by the ECB and OCA, steps into their shoes as the owner of the respective events under Section 54 (a) of the Copyright Act, 1957 and is thus entitled to file the present suit. In case the plaintiff is not granted an injunction protecting its rights against the defendants, the plaintiff is likely to suffer an irreparable loss and injury, which cannot be compensated in terms of money. I find the balance of convenience in favour of the plaintiff.*

11. *In view of the above discussion, the defendants no. 1 to 379 are hereby restrained from illegal broadcasting, transmitting, distributing or in any other manner communicating to the public the events of India Tour of England scheduled to be held from 03.07.2018 till 11.09.2018 and several sports events to be held in*

Indonesian cities of Jakarta and Palembang from 18.08.2018 to 02.09.2018 on the occasion of 18th Asian Games, 2018 till the next date of hearing without obtaining the written permission or licence from the plaintiff.

12. The defendants no. 380 & 381 i.e. Department of Electronics & Information Technology and Department of Telecommunications shall ensure that the ISPs are directed to block the websites of defendants no. 1 to 226, in case they are found to illegally broadcast or transmit the said events.

13. It is made clear that upon receiving the information that any other website is also indulging in such illegal transmission of the said events, the defendants no. 380 and 381 shall issue directions to block of those websites."

35. It is seen that convergence in media due to technological developments, is a fact of which judicial notice ought to be taken. The difference between traditional TV, computers, mobile phones, tablets etc., no longer exists. Most media platforms have converged in their functionalities. Computers are no longer merely used for word processing or viewing documents or for maintaining accounts - they are also sources of entertainment. Televisions are used nowadays for holding work meetings through video conferencing platforms Similarly, phones are not merely for telephonic communication but also for accessing emails, watching movies and videos etc. In this background, this Court is of the opinion that, this is a case where the joinder of causes of action against various types of platforms, i.e., Multisystem Operators and Local cable operators who transmit signals through television as also rogue websites who transmit through the internet, as Defendants in the same suit, ought to be permitted in one suit, in terms of Order II Rule 3 CPC.

36. There is no manner of doubt that the Asian Games which is a sporting

event that happen once every four years is globally watched by sports lovers and people in general, especially in the Asian continent. The event has a huge viewership and a large number of athletes and sportspersons across Asia participate in the event.

37. The intellectual property in the content, which is generated by the Plaintiff, in respect of the Asian Games, 2023 exclusively belongs to the Plaintiff in view of the license agreement dated 29th November, 2021 entered into with the OCA. The said content consists of various copyrighted works and the signals capable of being protected under the 'broadcast reproduction rights'. Thus, considering the past conduct of the rogue websites arrayed in this suit as also the MSOs/ LCOs which are impleaded in the present case, there can be no doubt that there is an imminent threat of illegal dissemination and communication as also piracy which would have to be restrained by the Court.

38. In the facts and circumstances of this case, Plaintiff has made out a *prima facie* case for the grant of interim injunction. The balance of convenience lies in favour of the Plaintiff. Further, the sporting event being live and the technological means which make it possible to immediately create further websites and move content from one platform to another, make it clear that irreparable harm would be caused to the Plaintiff if no *ad interim* injunction is granted. Apart from grant of the injunction, sufficient measures would have to be taken by all the stakeholders in order to ensure that illegal dissemination of the Plaintiff's copyrighted content is stopped.

39. In view thereof, relying on the judgment of the Id. Single Judge of this Court in *UTV Software Communication Ltd. and Ors. v. 1337Xto and Ors., 2019 (78) PTC 375 (Del)*, in order to protect the Plaintiff's rights in

various intellectual properties, which are likely to be violated on the websites of the Defendants, this Court directs as under:

- (i) Defendant Nos. 1 to 93 - the rogue websites and Defendant Nos. 94 to 108 - MSOs/ LCOs are restrained from broadcasting, telecasting, disseminating or communicating to the public any of the copyrighted content of the Plaintiff related to the Asian Games 2023 which may be telecasted by it on any of the Sony Sport Channels as also the OTT platform - Sony Liv without authorization and license from the Plaintiff;
- (ii) In addition to the aforementioned the rogue websites and MSOs/ LCOs the Plaintiff is also permitted to add further websites/ LCOs/MSOs which may be broadcasting, telecasting, disseminating or communicating unauthorized content relating to the Asian Games by filing an affidavit before the Registrar of this Court. Upon the said affidavit being filed, the injunction shall automatically extend to such websites and MSOs;
- (iii) The ISPs are directed to block all the websites/LCOs/MSOs arrayed as Defendant Nos. 1 to 108;
- (iv) The Domain Name Registrars - Defendant Nos. 140-145 shall block and take down all the websites/domain names arrayed as Defendant Nos. 1 to 93. *Status quo* shall also be maintained in respect of the said domain names and the same shall be locked/suspended with immediate effect. The Defendant Nos. 140-145 are restrained from transferring the said domain names or creating any third-party interest on the same.
- (v) Defendant Nos. 146-147 - DOT and MeitY shall issue blocking

orders in respect of all the rogue websites arrayed as Defendant Nos. 1 to 93 as also mirrors/alphanumeric versions of the said websites. The said order shall be issued by the DOT and MeitY within a period of one week from today.

For the sake of convenience of the names of the Defendants, the memo of parties of this suit is attached as **Annexure-A** to this order.

40. Considering the large number of defendants and their postal addresses being unavailable, compliance of Order XXXIX Rule 3 CPC be effected by e-mail within one week.

41. Reply to the application be filed within four weeks from the service of the present order, along with the paper book.

42. The Registry shall assist with service of notice of the injunction on "Ashok Kumars" / MSOs / LCOs as and when the Plaintiff is made aware of any un-authorized communication to the public of the Asian Games, 2023, from specific locations/head ends;

43. List this application before Court on 12th January, 2024.

I.A. 14785/2023 (u/O XXVI Rule 9 CPC)

44. This is an application filed by the Plaintiff seeking appointment of a Local Commissioners under Order XXVI Rule 9 of the CPC.

45. The Court has considered the matter and has granted an *ex parte ad-interim* injunction as recorded above in *I.A. 14784/2023*. Accordingly, in order to ensure that the injunction is fully complied with, it is deemed appropriate to appoint two Local Commissioners in respect of Defendant Nos. 94 to 108 who are MSOs and LCOs. If during the Asian Games, 2023, the Plaintiff comes across any unauthorised transmission of any of its content, it is permitted to take any of the following Local Commissioners for

conducting search and seizure.

46. Accordingly, the following are appointed as Local Commissioners in this matter:

- (i) Mr. Sharath Sampath, Advocate (M: 9818903313)
- (ii) Mr. Tejveer Singh Bhatia, Advocate (M: 9899528289)

47. The information, given by the Plaintiff about the Defendants' unauthorised distribution, shall be communicated to the Local Commissioners in writing as and when they are required.

48. The Local commissioners, upon receiving intimation from the Plaintiff shall be entitled to undertake the following steps in respect of Defendants 94 to 108 or any other MSOs/LCOs who may be found engaged in unauthorised distribution of the Asian Games content of the Plaintiff:

- (i) To visit the premises of Defendant Nos. 94 to 108, at the addresses which are provided by the Plaintiff, once it is made aware that such Defendants are indulging in illegal broadcast/telecast/exhibition or communication in any form or manner, to the public of the Asian Games, 2023 sporting event, or are otherwise infringing the Plaintiffs rights, including copyright, in the said event;
- (ii) To search the said premises of the Defendants and to make an inventory and take into custody all such equipment/wires/cables that are being used or could be used for the broadcast/telecast/exhibition or communication in any form or manner to the public of the Asian Games 2023 without permission from the Plaintiff, and to ensure that such Defendants are unable to illegally

broadcast /exhibit /communicate to the public the Plaintiffs content in any of its channels, including the Asian Games 2023, without obtaining prior permission from the Plaintiff;

- (iii) To visit the premises of any other entity as may be disclosed by the Defendants to be either the originator or a link in the chain of infringement of the Plaintiffs rights, and to make an inventory and take into custody all such equipment/wires/cables that are being used or could be used for the illegal broadcast /telecast /exhibition or communication in any form or manner, to the public of the Asian Games 2023, without obtaining prior permission from the Plaintiff;
- (iv) To sign all books of accounts including ledgers, cash books, purchases, and sale records etc. found in the said premises of the Defendants;
- (v) To pack and seal the same and thereafter hand them over on *Superdari* to the Defendants;
- (vi) To break open locks and enter the premises of the infringers in case of any obstruction/hindrane to entrance being caused, only in the presence and with assistance of the police;
- (vii) To make a sample recording of the illegal transmission, if possible;
- (viii) To take photographs and video of the proceedings, if deemed appropriate and necessary. Two representatives of the Plaintiff, which would include a lawyer, are permitted to accompany the Local

Commissioner;

49. Upon the request of the Local Commissioner, the concerned DCPs as also SHO of the location shall extend complete assistance to the Local Commissioner in executing the commission, as per this order, at the Defendants' premises.

50. The Local Commissioner, while executing the commission, shall ensure that there is no disruption to the business of the Defendants, except for the purposes of the execution of the commission. The commission shall be executed in a peaceful manner.

51. The order passed today shall be communicated by the Local Commissioners to the Defendants. Copy of the order and complete paper book shall be served by the Local Commissioners upon the Defendants at the time of execution of commission.

52. The fee of the Local Commissioners is fixed at Rs. 1,00,000/- plus out of pocket expenses, for each of the premises which they may visit as per the mandate specified above. The fee shall be borne by the Plaintiffs. The Local Commissioners shall file the report within two weeks of the execution of the commission.

53. List the application before the Court on 12th January, 2024.

54. Order *Dasti*.
